3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

(iv)Financial Soundness:

Tenders shall submit Average financial turnover **during last three years ending March, 2024 shall not be less t han Rs 2 lakhs.** Documentary evidence in the form of certified Audited balance sheets of relevant periodsor a certif icate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with bid. Profit & loss account statement to be submitted.

(v)Concurrent commitment: The bidder has to submit complete list of concurrent commitments on all jobs under execution by them, as per format given below, which will be taken into account to assess the spare capacity availabl e with the bidder.
