### **Scope of work:**

Ø Shifting of material from Central Store of IREL (India) Limited, OSCOM unit to the sites will be done by the party.

Ø Party will supply Hydraulic oil of minimum 40 Ltr for each machine.

Ø Party will supply switch board / extension board / cable / other accessories if required for electrical connection during installation of the machine.

Ø Party will carry out installation and commissioning of the machines at the site within 07 GPs surrounding OSCOM mine which is around 5- 10 KM distance from IREL plant.

Ø Party has to provide warranty certificate.

Ø The Hydraulic Paper plate machines will be handed over to SHGs who were trained in the sustainable Development training program conducted in FY 2024-25 in co-ordination with MBK/Sarpanch/Village Committee/District Administration.

Ø Party will supply stabilizer of minimum 5 KVA capacity to avoid voltage fluctuation and smooth functioning of the machine.

Ø Party will take proper care during shifting of Paper Plate machines to the distribution site. In case of any damage to paper plate machines during shifting, party will arrange for replacement/ repair of the same without incurring any additional cost to IREL.

Ø Party has to provide prompt service in rectifying the fault in case of getting complaint from beneficiaries/ IREL regarding malfunctioning of equipment.

Ø During the warranty period, in case of any defect/ damage to any components or spare parts of Hydraulic paper plate machine, party has to replace/ repair the same free of cost.

8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or

bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.**
