If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.

  2. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - 8. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. Buyer Added Bid Specific ATC

- 6. The bidder should have adequate physical infrastructure like Office/Repair Centre in Kanyakumari, Tirun elveli, Tuticorin or Thiruvananthapuram districts to guarantee quick service response. The details of availa ble infrastructure & its location with proof must be submitted along with the bid.
- 7. The bidder must upload the duly filled Technical Compliance sheet attached with the tender along with the specific make and model including brochure of the items to be supplied.
- 8. The bidder must submit documentary Proof of having experience in Similar Work in last 3 years and must have successfully executed/ completed with satisfactory completion certificate /letter.

- 3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 3.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units—are exempted from payment of EMD/ TDC—provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 4.0 SECURITY DEPOSIT (SD)
- 4.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

- 4.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 4.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 4.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 4.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.
- 5.0 Warranty: The warranty period for all the supplied items and the established CCTV Surveillance Syste m shall be for one-year (01) period from the date of successful commissioning of CCTV Surveillance Camer as System. This involves maintenance, repair or replacement of all faulty hardware covered under the cont ract (All components/ hardware parts, which enable CCTV Surveillance system fully functional). This will include all kind of breakdown maintenance and preventive maintenance excluding physical damage caused due to fires, floods & natural disasters.

#### 6.0 DELIVERY SCHEDULE:

- (i) Supply of materials should be delivered within 30 Days from date of award of contract at IREL.
- (ii) Installation, testing and commissioning at IREL, Manavalakurichi should be completed within 90 Days fr om the date of award of Contract.

- (iii) Warranty period: One (01) Year period immediately after the commissioning of the CCTV Surveillance C amera System.
- (iv) Annual Maintenance (AMC) shall be for a period of TWO (02) years after completion of the one-year wa rranty period.
- 7.0 Penalty for delay in service: Any defects in any of the cameras or in its accessories shall be repaired wi thin 24 hours from the time of reporting complaint in writing (Complaints through SMS, e-mails, WhatsApp etc. shall also be treated as complaints in writing). Any defects in any of the NVRs, switches, etc. leading t o breakdown of the system, shall be repaired/ replaced within 24 hours from the time of reporting complaint in writing. Any defects associated with the software shall be attended immediately, but not later than 0 3 days from the time of reporting complaint.

During the Warranty period, if the down time exceeds the above mentioned period, a penalty of 0.5% of the total value of contract (Excluding AMC charges) shall be levied as penalty for each week of delay.

During the AMC Period, if the down time exceeds the above mentioned period, penalty will be deducted from the due payment of AMC @0.5% per week of the yearly AMC value of the contract.

#### 8.0 PAYMENT TERMS

- a. 70% on receipt of all the approved BOM quantity at site in good condition except cables.
- b. 20% on installation, testing and commissioning of the system including actual cable used for setup.
- c. 10% will be retained as Performance Guarantee of the total value (including GST) till completion of warr anty (01 year) period.
- d. AMC charges after warranty period: After end of each quarterly period on commencement of AMC upon submitting satisfactory report of service duly certified by end user.

All payments are subject to deduction of tax at source as applicable.

#### 9.0 LIQUIDATED DAMAGES:

- 1. The liquidated damages shall be applicable only from the date of approval of the GA Drawing of the syst em and other documents mentioned in the NIT by the EIC/ Officer In-charge.
- 2. In case of delay in completion of the contract, liquidated damaged are to be levied as below:

For delays attributable to the contractor liquidated damages shall be levied at the rate of 0.5~% per week o r part thereof on the value of unfinished supply/work for each week of delay subject to a maximum of 10~% of the total contract value.

- 10.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall go vern.
- 11.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 12.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
