1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

1. Tenderer should have minimum 2 Nos of crawler mounted excavator of minimum of 0.9 cu.m capacity a nd minimum 1 Nos of tyre mounted Wheel Loaders of min.1.5 cu.m in their own name or through hiring wh ose Manufacturing date should be later than 01/07/2020. Documentary proof of the owning or hiring to be submitted. List of Excavators and Loaders with the Documentary proof for their manufacturing date, Owne rship status and capacity also is to be submitted.

(Intending tenderers have to furnish documentary evidence in support of the owning or in case of hiring, c opy of agreement with supplier to be submitted. - 2. The tenderer must have experience in successful completion of similar works during the last 7 years ending 31.05.2025 and the same should be either of the following:

OR

2 One similar work costing not less than ₹3,80,80,000/-

(1) Mechanized excavation, loading and transportation by road

3. The tenderer's average annual financial turnover during the last 3 (three) financial years ending 31.03.2 024 should be at least ₹1,42,80,000/-. (Copies of profit & loss account and balance sheets for the last 3 ye ars duly audited by statutory auditor are to be submitted).

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be conside red under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Depar tment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying wi th the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

OTHER TERMS & CONDITIONS

- 1.0 Bidders have to upload the following along with the Bid
- (i) Documents towards pre qualification of tender failing which offer shall not be accepted.
- (ii) Copy of Valid GST, PAN, MSME Registration
- (iii) EMD Declaration
- (iv) Undertaking provided in tender, duly filled and signed
- (v) Contact details with e-mail, Phone no. etc.
- 2.0 The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied strictly as per the technical specification within the delivery period mentioned in the tender.
- 3.0 Earnest Money Deposit (EMD)
- 3.1 ₹9,52,000/- (Rupees Nine lakh and fifty two thousand only)
- 3.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.
- 3.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should conta in full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details includin g amount, and UTR No. and bank details from which payment was done. - 3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting t he order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.

- 3.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units—are exempted from payment of EMD/ TDC—provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 4.0 Security Deposit (SD)
- 4.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

- 4.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 4.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 4.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 4.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.
- 5.0 period of Contract:

The period of contract shall be ten (10) months from the date of start of work or the quantity which is to be transported, whichever is earlier.

6.0 Works during all weekly days:

The contractor shall carryout the works in two shifts on all working days. The shift timings are from 7.00 A M to 3.00 PM and 3.00 PM to 11.00PM. For carrying out the work on Sundays/holidays prior permission from IREL has to be obtained.

- 7.0 Payment Terms:
- a. Payment to the contractor for the work done will be made fortnightly on production of bills and after th e verification of work done with weighbridge statement generated by stores department within 30 days f rom the submission of bills complete in all respect. Penalty for shortfall and deduction as per the variou s clauses in the tender as applicable will be made including statutory deduction such as Income Tax, etc. a s per rules.
- b. No mobilization advance shall be allowed as a general rule.
- c. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the GST/SGST Act 2017, Section 20 of the IGST Act. 2017 and Section 21 of the UTGST Act. 2017.
- d. Please mention IREL (India) Limited GST number (33AAACI2799F1ZL) and HSN/SAC code of goods/servic es in your bills.
- e. All payments shall be done only through E-payment. Hence successful bidder has to provide Company n ame, Account number, Name of the bank.
- 8.0 Penalty:
- 8.1 Mobilization period & penalty due to delay in mobilization:

Time is the essence of the contract. The Contractor shall commence the work after completion of vocation

al training to the persons engaged by him within the date as mentioned in work order. In case of delay in the start of work, a penalty of Rs. 25,000/- per day will be charged for every day's delay in start of work (providing minimum two loading equipment and four tippers). However, IREL has got the liberty to accept less number of equipments at its own discretion. If the equipments are not mobilized within 20 days from the above date of receipt of LOI/WO, the contract is liable to be cancelled at the discretion of IREL and the security deposit/EMD as the case may be will be forfeited. IREL is also at liberty to get the balance work done from other sources at the risk and expenses of the contractor. The contractor shall not be entitled to gain anything out of such arrangement.

- 8.2 No penalty will be deducted for work done upto 30 days from the date of starting of work provided the contractor transports at least 60% of the target quantity during the above period. Failure to do so will result penalty as per mentioned Scope of Work clause C (3.0).
- 8.3 The contractor will have to mobilize his equipments and men two days prior to start of work or checkin g of the same.
- 8.4 The equipments mobilized may be owned by the contractor or by sister concerns in the case of Compa nies and documents to this effect has to be produced by before starting the work. However, hired equipm ents may be allowed after prior permission from IREL.
- a) The Contractor shall inform the company immediately the date on which the work is commenced. The d etails of all the equipments like Excavator, loader, tippers and manpower to be employed for the purpose will be furnished along with all fitness, statutory certificates in original for verification at least two days in advance for safety clearance prior to start of work.

9.0 Risk Purchase Clause:

After award of the contract, if the contractor fails to execute the contract as per tender or at any time repu diates the order, IREL have the right to forfeit the EMD/SD and execute the contract through other agencie s at the risk and cost of the contractor. The cost differences between the alternative arrangements and tot al contract value will be recovered from the contractor along with other incidental charges. In case of exec ution of contract through alternative sources and if price is lower, no benefit on this account will be passed on to the contractor.

10.0 Liquidated Damages for Delayed Execution of Contract:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be fin all and binding.

- 11.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall go vern.
- 12.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 13.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
