1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder

shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.

2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. Buyer Added Bid Specific ATC

#### PRE-OUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

#### 1. Technical:

Experience of having successfully completed similar works during last 7 years ending 31st August 2025 and the same should be either of the following. The tenderers should produce copy of work o rder in support of the same with satisfactory completion certificate from concerned authority / dep artment/organization for similar works (documents to be submitted endorsing work experience).

a) Three similar works, each costing not less than ₹1,87,819/- (incl. GST 18%)

(OR)

b) Two similar works, each costing not less than ₹2,34,774/- (inclu. GST 18%).

(OR)

c) One similar work, costing not less than ₹3,75,638/- (inclu. GST 18%).

Definition of similar work: Similar works means works involving cleaning of building.

#### 2. Financial:

Average annual financial turnover during the last 3 years, ending 31st March 2024, should be at le ast ₹1,40,864/- (inclu. GST18%). (Copies of profit & loss account and balance sheets for the last 3 years are to be submitted) or IT return duly filed duly audited by statutory auditor.

#### Note:

1. The bidder must have functional office established in the State of Tamilnadu/Kerala as on 31st August 2025.

Bidder shall submit proof of registration of such office as per the Tamil Nadu Shops & Establishme nt Act 1947 with address proof or equivalent in Kerala State

- 2. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.
- 3. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Department of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
- 4. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract shall not be considered.
- 5. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procure ment Policy for Micro and small Enterprises, 2012 (as amended time to time).

#### OTHER TERMS & CONDITIONS

- 1.0 Bidders have to upload the following along with the Bid
- (i) Documents towards pre qualification of tender failing which offer shall not be accepted.
- (ii) Copy of GST, PAN, MSME Registration
- (iii) EMD Declaration
- (iv) Undertaking provided in tender, duly filled and signed

- 2.0 Earnest Money Deposit (EMD)
- 2.1 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalaku richi.
- 2.2 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail shou ld contain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, paymen t details including amount, and UTR No. and bank details from which payment was done. IREL's E mail id is purchase-mk@irel.co.in
- 2.3 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of open ing of Techno-Commercial Bid.
- 2.4 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.5 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after ac cepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.6 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and ap proval. MSME /SSI units are exempted from payment of EMD/ TDC provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 3.0 SECURITY DEPOSIT (SD),
- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towar ds satisfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after noti fication of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).

- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bo nds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalised Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of B ank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply/ work order.

#### 4.0 PENALTY:

Contractor should carry out the work as per the scope of works. If the contractor fails to carry

out as per scope of work, a fine will be imposed at the rate of ₹500/- per day each area for the per iod of non execution of the work.

5.0 WORKING HOURS: Work hours shall be between 8.00 AM to 4.00 PM on all working days, holid ays & Sunday (after allowing for formalities connected with documentation, site briefing etc). Ho wever based on a written request from the contractor IREL (India) Limited may consider, in deserving conditions, extension of working hours beyond what is stipulated above and such extension shall be granted formally.

#### 6.0 PERIOD OF CONTRACT

a. The work shall be commenced within 15 (fifteen) days from the date of issue of work order.

Within this period (i.e. 15 days) contractor should complete all the statutory training i.e. Vocationa I Training (VT), etc. for their employees.

- b. The period of contract shall be 1 (one) year from the date of commencement of work.
- c. The company reserves the right to terminate the contract without assigning any reason by givin g two week notice and no claim for any loss or damage or compensation for such termination of contract shall be payable by the company or maintainable against the company.

#### 7.0 PAYMENT

- a. Payment will be made based on mandays only along with PF & ESI contribution of contractor sh all be reimbursed based on the proof towards the same. Payment for the mandays engaged shall b e done on monthly basis.
- b. The final bill, in all respect should be submitted by the contractor within 30 days from the date o f completion of work.
- c. After completion of work all deposits will be released along with final bill.
- d. Payment will be made within 30 days of certification of contractor's bill by engineer-in charge/of ficer-in-charge.
- e. All payments are subject to deduction of tax at source as applicable.
- f. GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CGST/SGST act 2017, s ection 20 of the IGST act 2017 and section 21 of the UTGST act 2017.
- g. Our GSTIN 33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.
- h. All the payment will be done only through e-payment. Hence, you have to provide your name, a ccount no., name of the bank, nature of account (savings/current/CC/OD), IFSC, branch code and c ancelled check along with invoice.

#### 8.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) specified in the CONT RACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liq uidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

9.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC s hall govern.

10.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipul ated by IREL shall govern.

11.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake don e by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Li mited shall not be anyway held responsible.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1

- bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
