The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized estimated value of the work under consideration exceeds 4 times the average annual turnover of the preceding 3 years. The bidder shall submit financial standing through latest Income Tax return (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods.

The bids qualifying PQ-1, PQ-2, & PQ-3 only will be considered for further processing.

Period of Contract:

The period of contract shall be 90 working days from the date of issue of work order or completion of the estimated quantity 70,000 MT, whichever is earlier. Since the work is a part of Disaster Management activity, the successful tenderer shall commence the work with 48 hours of issuing work order or date of intimation by EIC. If there is a delay in start the work beyond 48 hours, penalty will be levied @ of Rs.5,000/- per day and company will make alternate arrangement at the risk & cost of the successful tenderer.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-
