Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. Buyer Added text based ATC clauses

PRE-QUALIFICATION CRITERIA

<u>Tenderer should submit the following documents towards Pre-Qualification Cr</u> <u>eria</u>

- Tenderer shall submit copies of Purchase/Work Orders for "diesel operated ride-on weeper machine with hydraulic dumping system" supplied by them with reputed pa es during the last three years
 - a) Three similar orders each costing not less than Rs.12,00,000/-

(or)

b) Two similar orders each costing not less than Rs. 15,00,000/-

(or)

- c) One similar order each costing not less than Rs. 24,00,000/-
- Average annual turnover of the tenderer during the last 3 years, ending 31 st March, 2022 should be R: 00,000/- (Documentary proof of the above should be enclosed). The tenderer shall submit copy of P & L count / IT return / turnover certificate for the last three years.

- 3. The offers of the bidders who have defaulted in the past in execution of the contrast s or in complying with the obligations as per the contract shall not be considered.

4. Concurrent commitment:

The bidder has to submit complete list of concurrent commitments on all jobs under execution by them s per format given below, which will be taken into account to assess the spare capacity available with t

bidder. If the annualized concurrent commitments of the bidder plus annualized estimated value of the rk exceeds four times the average annual financial turnover during the last three financial years of the der, then the bid of such a bidder shall not be considered for further evaluation.

Concurrent commitment of the bidder shall be evaluated as on the last day of the Month previous to biue date, based on the confirmation/declaration of the bidders that they have disclosed all works being ecuted by them. Bidders shall exclude all stalled project for which there is no progress in last one year eng reason for no progress considering above cut-off date. In case any adverse report/complaint are reced against bidder and on enquiry found correct, offer shall be rejected and bidder shall be liable for appriate legal action.

Terms & Conditions

1.0 Bidders have to upload the following along with the Bid

- (i) Documents towards pre qualification of tender failing which offer shall not be ccepted.
- (ii) Copy of GST, PAN, MSME Registration.
- (iii) Undertaking provided in tender, duly filled and signed.
- (iv) Contact details with e-mail, Phone no. etc.

The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied strictly as per the technical specification within the delivery period entioned in the tender.

2.0 Delivery Period

The delivery schedule shall be 30 days from the date of acceptance of the Purchas Order

3.0 Earnest Money Deposit (EMD)

- 3.1 Rs.60,000/- (Rupees Sixty thousand only)
- 3.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.
- 3.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The -mail should contain full postal address of the Tenderer, Tender No. for which EMD TDC were paid, payment details including amount, and UTR No. and bank details m which payment was done. - 3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the for at given in the tender. The Original BG shall reach this office at least 3 days in adv ce from the date of opening of Techno-Commercial Bid.
- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his quot

on subsequent to the date of opening.

- ii. The tenderer fails to accept the order when placed or fails to commence suppl /works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order
 3.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to req st and approval. MSME /SSI units are exempted from payment of EMD/ TDC proved they submit valid MSME/ NSIC certificate along with commercial bid and to ensu that certificate pertains to the class of item/works for which floated.

4.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit **@5% of the contract val** in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for sa factory completion of the order. The SD shall not bear any interest and is liable to forfeited for unsatisfactory completion or on abandonment of the supply order. The MD can be adjusted towards Security Deposit. However, if EMD is submitted in the rm of BG, fresh BG is to be submitted towards SD in the prescribed format as per t der. If the Supplier fails to provide the security deposit within the period specified, ch failure shall constitute a breach of the Contract and IREL shall be entitled to ma other arrangements for the repurchase of the stores contracted for at the risk and pense of the supplier and/or to recover from the supplier the damages arising fron uch cancellation.

5.0 Installation and Commissioning:

Successful bidder has to do installation, commissioning and demonstration of the equipment at our Mk ant and necessary on site support and training to be given to the operators for the safe operation of maine.

6.0 Warranty:

The materials/equipment and all accessories supplied shall be warranted against any defective materi malfunctioning or poor workmanship for a minimum period of 12 months from the date of commissionir installation or 18 months from the date of acceptance of supply, whichever is earlier.

7.0 Payment terms

90% payment along with 100% taxes and duties shall be made towards supply as nst tax invoice within 30 days of receipt & acceptance of the equipment at IREL (Ir a) Limited, Manavalakurichi Stores.

Balance 10% shall be paid 12 month after successful operation of the equipment 18 months from date of supply whichever is earlier.

Alternatively, the balance 10% will be paid on submission of Performance Bank Gu antee (PBG) by the Supplier for 12 months from the date commissioning OR 18 mc hs from the date of supply whichever is earlier. The PBG should have an additional aim period of 3 months.

Security deposit will be released on receipt & acceptance of the equipment at IREL ndia) Limited, MK Stores. The party has to quote terms of price FOR MK unit, Mana lakurichi, Kanyakumari District, Tamil Nadu.

8.0 Liquidated Damages

Subject to Article -32, if the SELLER fails to deliver any or all of the GOODS or performance the services thin the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other medies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the NTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each we or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delayed g ds. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proport ately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may deduct e amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against the rformance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction e genuine pre estimates of the loss/damage which the PURCHASER would have suffered on account of ay/breach on the part of the SELLER and the said amount will be payable on demand without there bei any proof of the actual loss/or damage caused by such breach/delay. A decision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated under buyer ATC shall vern.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
