Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 2. Bidder shall submit the following documents along with their bid for Vendor Code Creation:
 - a. Copy of PAN Card.
 - b. Copy of GSTIN.
 - c. Copy of Cancelled Cheque.
 - d. Copy of EFT Mandate duly certified by Bank.
- Bidders can also submit the EMD with Account Payee Demand Draft in favour of IREL (India) Limited payable at chavara

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

 Bidders can also submit the EMD with Banker's Cheque in favour of IREL (India) Limited payable at chavara

Bidder has to upload scanned copy / proof of the BC along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

6. Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also

(besides PBG which is allowed as per GeM GTC). DD should be made in favour of IREL (India) Limited payable at chavara . After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

- 7. Scope of supply (Bid price to include all cost components) : Only supply of Goods
- 8. Buyer Added text based ATC clauses

1.PRE QUALIFICATION CRITERIA FOR FABRICATION AND SUPPLY OF GI GRATINGS

- 1. The tenderer should be a manufacturer or dealer for supply of GI Gratings. The manufacturer shall submit t self-declaration towards being manufacturer or submit Udyam certificate indicating the nature of busines s. Dealer shall submit valid authorization certificate from the manufacturer.
- 2. The tenderer shall submit copies of purchase order for supply of GI gratings to any Central / State Govt. / Public Sector Undertaking / Private organization during last 7 years ending April'24. Documentary evidence towards the supply executed for GI gratings viz. Copies of the purchase order and invoice (and / or) receipt of bank payment details or document towards acceptance of the item / satisfactory performance certificat e should be enclosed.

The average financial turnover of the tenderer during last 3 years ending 31st March 2023/2024 shall not be less than INR 2.53 lakhs or the tenderer should submit GST registration certificate Financial statement s (audited P&L account / IT returns for the above period is to be submitted). Start up units are exempted f rom submitting financial standing.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
