Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracter rates. Bidders are bound to accept the orders accordingly.
- 2. Buyer Added text based ATC clauses

PRE-QUALIFICATION CRITERIA

Bidder should submit the below documents towards Pre-Qualification Criteria

1.0 <u>Technical Competency:</u>

- a) Original Equipment Manufacturer (OEM) of Spiral concentrator or their Associat thorized dealers/ agents are eligible to participate in the tender. Associate/Aut ed dealers / agents are required to submit authorization letter from OEM.
- b) The bidder should have experience of supply of spirals, minimum 24 starts to mineral sand industry or mineral sand research centre during the last seven y ending 31.07.2024. In proof of the same, the bidder should submit Copy of the hase order and proof of completion certificate/ performance certificate.
- c) GA drawing to be submitted of the spiral along with the offer.
 - Authorized dealers/agents submitting offer can give the experience proof of su of their principals for the supply of spirals.

2.0 Financial Soundness:

Average Financial turnover of the participating bidders during last three years ending 1st March 2024 shall not be less than Rs. 28,54,098/- or equivalent foreign current nancial Statements (Audited balance sheet Profit & Loss Account/ IT Returns/ certif opy of Chartered Accountant) for the above periods is to be submitted. In case of c/ Private Limited companies, Published annual accounts will be accepted.

Documents against the Pre-qualification criteria as above complete in all respect r be attached/ uploaded in the e-procurement portal. Failure to compliance of above I make the bid incomplete and as such it shall be rejected

General Requirements:

Bidder should attach the following documents (applicable in case of Indian bidders Indian authorized agents of foreign manufacturers):

- 3.0 Earnest Money Deposit (EMD)
- 3.1 Rs. 1,61,248/- (Rupees One lakh sixty one thousand two hundred and forty eight only)
- 3.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited avalakurichi.
- 3.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The mail should contain full postal address of the Tenderer, Tender No. for which EMD & C were paid, payment details including amount, and UTR No. and bank details from the payment was done. - 3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the fo given in the tender. The Original BG shall reach this office at least 3 days in advanment the date of opening of Techno-Commercial Bid.
- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his quota

- subsequent to the date of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence suppl orks after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order PSU, State Govt. Undertakings are exempted from payment of EMD subject to req and approval. MSME /SSI units are exempted from payment of EMD/ TDC provid ey submit valid MSME/ NSIC certificate along with commercial bid and to ensure th rtificate pertains to the class of item/works for which floated.

4.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit @5% of the contract val the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for satis ry completion of the order. The SD shall not bear any interest and is liable to be fo d for unsatisfactory completion or on abandonment of the supply order. The EMD of e adjusted towards Security Deposit. However, if EMD is submitted in the form of I esh BG is to be submitted towards SD in the prescribed format as per tender. If the plier fails to provide the security deposit within the period specified, such failure so onstitute a breach of the Contract and IREL shall be entitled to make other arrange ts for the repurchase of the stores contracted for at the risk and expense of the supplier to recover from the supplier the damages arising from such cancellation.

5.0 Regulations, Acts, Standards & Codes to be followed:

The design, manufacture, supply to site and testing of the equipment covered in the ecification shall comply with the appropriate standards amended up to March, 20.1 nless otherwise specified, Indian Standards shall be followed. In case where suitable dian Standards are not available, generally accepted codes and practices as mutual greed upon shall be adopted. The equipments shall comply with the statutory requents of the Govt. of India. The equipment and installation shall conform to the plant of statutory and other regulations in force. The successful bidder shall provide ecessary support like drawings, data etc as required by the statutory authorities. It es where the offer deviates from the specified standards, bidder shall indicate cle in his offer the standards proposed to be adopted by him and the details thereof.

6.0 Scope:

The scope of supply includes and not limited to,

Supply of Bank of 4, Twin start, 4 Turn Very High Grade Spira I concentrator in one bank,
 i.e one bank consisting of 2 parallel rows of 2 twin start spirals in each row (total 1 x 2 x 2 x 2 =8 starts) along with accessories as per technical specification enclosed. (One botto m entry Open / Gravity distributor with 8 outlets and 3 launder s for products i.e., concentrate middling and tailings).

7.0 Time Period of Completion:

The delivery should be 210 days from the date of Purchase order.

Suppliers are required to deliver on FOR Destination basis i.e. IREL (India) Liud, Manavalakurichi, Kanyakumari District. Tamil Nadu State, India. Pl 629252.

Order acceptance should be confirmed within one week from the date of issue of tame from our end and Security Deposit is to be submitted within 30 days from the e of issue of the Purchase Order.

8.0 Terms of Payment:

a) On delivery:

90% payment of the contract price shall be paid on receipt of goods at IREL (India) Limited, Manarichi – 629 252, Kanyakumari Dist., Tamil Nadu, India in good condition and upon the submission o ollowing documents only:

- (i) Copies of supplier's invoice showing contract number, goods description, c ity, unit price and total amount;
- (ii) Consignee Receipt Certificate in original issued by the authorized represer e of the consignee;
- (iii) Two copies of packing list identifying contents of each package;
- (iv) Manufacturer's / supplier's guarantee/ warranty certificate.
- (v) Certificate from the manufacturer / supplier to the effect that the goods of m to the manufacturers standards and are new and free from any latent of ent defects and are strictly as per Specifications mentioned in Tender.
- (vi) Certificate of origin if applicable. (Atleast within 7 days after payment)
- b) Balance 10% payment of the contract price along with SD amount shall be ma nly after successful performance test at IREL, Manavalakurichi and on receipt c formance Bank Guarantee. The Performance BG will be released after complet f the guarantee period of 12 months from date of successful commissioning/ 1 nths from the date of supply, whichever is earlier.

All bills/ invoices are to be certified by EIC. The successful bidder should ensuoduction of required documents for availing input tax credit, if available.

Our standard payment term is "100% payment of payable amount within 30 d rom the date of receipt and acceptance of materials along with all relevant doc nts". NO advance payment shall be made under any circumstances.

GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGS ST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act 7.

9.0 Performance Guarantee:

Party should give guarantee for a minimum period of 12 months from the date of 18 months from the date of supply, whichever is earlier. The guarantee shall compof the following:

- i) Materials supplied
- ii) Workmanship
- iii) Performance tests as mentioned in technical specification

10.0 Warranty:

The materials/equipments and all accessories supplied shall be warranted against any defective materia unctioning or poor workmanship for a minimum period of 12 months from the date of use 18 months from date of supply, whichever is earlier.

11.0 Prices:

All the rates stipulated in the Schedule of Prices shall be all-inclusive and firm thro ut the relevant periods of contract as detailed in the said schedule including during periods of further extension if any.

The price indicated in the bid shall stand firm without any escalation on any account till this order is cc

ely executed.

12.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or perforce the services within the time period (s) specified in the CONTRACT, the PURCHA shall, without prejudice to his other remedies under the CONTRACT, deduct from ONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including equent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delive ate, for each week or part thereof of delay. The total damages shall not exceed 10) per cent of the value of delayed goods. The LD cannot exceed the amount stipular the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shal educed proportionately for the delay and payment shall be released accordingly. In the event the invoice value is not reduced proportionately for the delay, the PUI SER may deduct the amount so payable by SELLER, from any amount falling due to SELLER or by recovery against the Performance Guarantee. Both seller PURCHASER agree that the above percentages of price reduction are genuine predates of the loss/damage which the PURCHASER would have suffered on account of y/breach on the part of the SELLER and the said amount will be payable on deman hout there being any proof of the actual loss/or damage caused by such breach/dadecision of the PURCHASER in the matter of applicability of price reduction shall nal and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated unduyer ATC shall govern.
