- a. Evaluation of the technically qualified offers as per pre-qualification c riteria shall be done based on the total landed price at IREL(India) Lim ited, OSCOM
- b. Parties who have defaulted in execution of contracts in previous inst ances at IREL (India) Limited, OSCOM shall not be considered.
- c. IREL (India) Limited reserves the right of division of the works/Bill of Quantity among various tenderers to the advantages of IREL. The ten derers on their part shall accept such part (split) offered by IREL (Indi a) Limited. The splitting of the quantity amongst more than one tende rer can be in the ratio of 60:40 at the rate offered by the overall lowes t bidder.
- d. EMD: This is a Mining Contract. Bidder having mining services in UDY AM CERTIFICATE is eligible for EMD exemption.

**3)**Note: As per para **7.3.5** on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2022, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not compl y or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offere d or permitted. No post bid clarification at the initiative of the bidder shall be entertained. The shortfall i nformation / documents should be sought only in case of historical documents which pre-exist ed at the time of the tender opening and which have not undergone change since then. So far a s the submission of documents should be asked for and considered. For example, if the bidder ha s submitted a supply order without its completion / performance certificate, the certificate can be asked for and considered. However, no new supply order should be asked for so as to qualif y the bidder.

## Disclaimer

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

- 7. Floating / creation of work contracts as Custom Bids in Services.
