The bidder should be an experienced service provider for Excavation, collection, loading, transportation an d delivering of mineral sand OR any sand from mining areas to designated sites

Mechanical loading, transportation and levelling of tails sand or mineral sand or any sand.

Mechanical loading, transportation of boulders or any other similar minerals.

Tender stipulation on prior experience:

To meet the above experience criteria,

The bidder should have successfully completed similar service contracts during the last seven years endin g 30.09.2024 meeting any of the following:

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized esti mated value of the work under consideration exceeds 4 times the average annual turnover of the precedin g 3 years. The bidder shall submit financial standing through latest Income Tax return (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
