If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. I) Pre-Qualification criteria:

This is a Limited tender and bidders should have registered with IREL (India) Limited, OSCOM for Cleaning of toilets, bathrooms and sweeping/mopping work can participate in the tender. However, vendor registration certificate to be attached along with the bid.

NB: a) Bidder submitting sub contracts PO/WO should submit tripartite agreement and labour license, failing which offer shall not be considered.

b) Party should upload the Scope of work duly signed & sealed during bidding.

c) Bidder shall upload Price break-up as per attached Excel BOQ sheet during Bidding under price bid only. Disclosing price CST before financial bid opening will liable for rejection of offer.

d) Uploaded BOQ table's Gross total including GST must be same with quoted Lumpsum value on GEM portal. Lumpsum value quoted on GEM portal is final and treated as inclusive all BOQ items.

e) Bidder has to quote Fixed Misc Lumpsum charges amount of (Part B) of BOQ price breakup i.e. Bidder has to quote the exact lumpsum fixed charges amount of "Rs. 49,560/-" in the header "Consumables to be provided by Service Provided Addon Price" of the financial bid on GEM portal, failing which the offer shall be rejected.

f) Quantity may increase/ decrease as per the actual requirement.

II) **SD / EPBG:** Please furnish Security Deposit (SD) @ 5% of the total order value (Excluding GST) within 14 days of receipt of this order in the form of demand draft / RTGS. Alternatively, you may furnish an irrevocable Bank Guarantee for the said amount. The BG should be issued by SBI including its subsidiaries or Nationalized Bank or any schedule 'A' Commercial Bank approved by RBI. BG given by Co-Operative banks will not be accepted. BG shall not bear any interest and is liable to be forfeited for unsatisfactory completion or an abandonment of the supply. The same shall be refunded to you after successful completion of work and after due clearance by user department.

Note: If successful bidder did not remit SD within 14 days of receipt of order, Penalty of 10% per annum shall be levied for delayed remittance of security deposit.

III) **Liquidated Damages (LD):** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as pre-estimated damages not exceeding 5% of the total contract value without any controversy/dispute of any sort whatsoever.
