XII. Special Conditions Of Contract

## **SCOPE OF CONTRACT/WORK:**

Supply of **5** nos of 5 TPH **Induced Roll Magnetic Separator (IRMS)** of proven design used for m ineral separation as per detailed specification terms and conditions furnished in the tender including transportation to OSCOM stores on FOR Destination basis.

Unloading will be done by IREL at OSCOM stores

Erection and commissioning of equipment shall be done by IREL at its site. The supplier shall exte nd supervisory support for commissioning of the equipment, if required by IREL, at no extra cost t o IREL.

#### Time period of completion:

The delivery schedule shall be **40 weeks** from the date of approval of GA drawing. The GA drawing shall be furnished to IREL (India) Ltd within 7 days from the date of receipt of the purchase order

(Total period will be 32 weeks for delivery and 8 weeks for commissioning)

# **Terms OF PAYMENT**

- a. 90% payment along with 100% taxes and duties shall be made towards supply against tax invoice within 30 days of receipt of the equipment at IREL, OSCOM Stores.
- b. Balance 10% shall be released after successful commissioning of the equipment OR on expiry of 8 weeks from date of supply whichever is earlier.

## Note:

- i. EPBG/BG shall be released on satisfactory performance of the equipment during the entire warra nty period (12 months from the date commissioning OR 18 months from the date of sup ply whichever is earlier).
- ii. The bidder shall quote on terms of price FOR OSCOM unit, Matikhalo, Ganjam Dt, Odisha. The ra te quoted shall be in Indian Rupees only and commissioning supports shall be provided at site, if r equired by IREL at no extra cost .

iii. If any bidder proposes for a payment term other than the above, IREL reserves the absolute rig ht to accept or reject the term and decision of IREL shall be final and binding to all the parties. # PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioratio n, damage or breakage during shipment, handling and storage in a tropical climate, ideally in woo den cartons. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated

# **INSURANCE:**

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or dama ge during transportation/shipment and handling. For delivery of goods to the purchaser's premises , it is advised that insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

# TRANSPORATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM shall be done by the contractor at their risk and cost.

## **UNLOADING, HANDLING:**

- a. Unloading at site shall be done by IREL at its cost.
- b. Any incidental expenses at IREL other than unloading charges shall be borne by the supplier
- c. Procedure for unloading and handling shall be communicated by the supplier to IREL well in adv ance.

#### **INSPECTION**

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your rep resentative for carrying out joint inspection at site or else IREL may conduct inspection on its own. If it is found that any item does not conform to the specification given, or is defective in any mann er, the same will be rejected and supplier should arrange for immediate replacement thereof, free of cost to us inclusive of all taxes and duties. Such replacement supplies will also be subjected to our inspection as above before acceptance. However, such supplies, if delayed beyond the period of contract will be considered as late supply and will attract Liquidated damages.

#### **TESTING AND COMMISSIOING:**

IREL will install the machine at its site within a period of **2 months** from the date of delivery and s hall test and Commission of the entire system at site.

If so, required by IREL, the manufacturer's / supplier's trained engineer/ technician shall extend ne cessary technical supervisory supports during installation and commissioning.

#### FINAL ACCEPTANCE CERTIFICATE (FAC):

The FAC will be issued by the PURCHASER only on demonstration of the technical specifications. T he warranty shall commence only from the date of the issuance of the FAC.

#### **DOCUMENTS TO BE SUBMITTED:**

The following documents (in English) shall be provided along with the Unit in both hardcopy and s oftcopy forms:

- a) Unloading and Handling procedures.
- b) Operation and maintenance manuals
- c) Troubleshooting procedures

- f) If there are any bought-out systems and components, manuals of these are desirable to be provided in hard/softcopy.
- g) Safety and security instruction manual should be provided.

#### LIQUIDATED DAMAGES FOR DELAY IN EXECUTION OF CONTRACT
