13.SPECIAL CONDITIONS OF CONTRACT

Supply of 1 no. Low Intensity Wet Magnetic Separator (LIMS) of proven design that can process 145m 3 /Hr slurry used for removal of highly magnetic trash material in mineral separation plant as per detailed specification, terms and conditions furnished in the tender.

Unloading will be done by IREL at its expense.

The supplier shall extend supervisory support for commissioning of the equipment, if required by IREL, at no extra cost to IREL.

TIME PERIOD OF COMPLETION: The order shall be fully supplied within 196 days (28 weeks) from the da te of acceptance of GA drawing. GA drawing shall be submitted within 7 days of release of order.

TERMS OF PAYMENT

a. 90% payment along with 100% taxes and duties shall be made towards supply against tax invo ice w ithin 30 days of receipt & acceptance of the equipment at IREL, OSCOM Stores.

b. Balance 10% shall be paid after successful erection and commissioning of the equipment or 06 mont hs from date of supply whichever is earlier.

C. If any bidder proposes for a payment term other than the above, IREL reserves the absolute right to accept or reject the term and decision of IREL shall be final and binding to all the parties. For e valuatio n of offers, loading shall be made at the rate of 12% per annum for variations in payment terms.

MODE OF PAYMENT:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, da mage or breakage during shipment, handling and storage in a tropical climate, ideally in woo den carto ns. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of rep uted make. Large items shall be individually crated.

MARKING ON PACKAES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Name & Address (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference number.

INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage d uring transportation/shipment and handling. For delivery of goods to the purchaser's premises, it is advi sed that insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the go ods from "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and St rikes.

TRANSPORATION:

UNLOADING, HANDLING: Unloading at site shall be done by IREL at its cost. Any incidental expenses at IREL other than unloading charges shall be borne by the supplier Procedure for unloading and handling shall be communicated by the supplier to IREL well in advance.

INSPECTION

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your re pres entative for carrying out joint inspection at site or else IREL may conduct inspection on its ow n. If it is f ound that any item does not conform to the specification given, or is defective in any manner, the same will be rejected and supplier should arrange for immediate replacement thereof, free of cost to us inclu sive of all taxes and duties. Such replacement supplies will also be subjected to our inspection as above before acceptance. However, such supplies, if delayed beyond the period of contract will be con sidered as late supply and will attract Liquidated damages.

TESTING AND COMMISSIOING: IREL will install the machine at its site within a period of 3 months from t he date of delivery and shall test and Commission of the entire system at site. If so, required by IREL, t he manufacturer's / supplier's trained engineer/ technician shall extend necessary technical supervisor y supports during installation and commissioning.

FINAL ACCEPTANCE CERTIFICATE (FAC):

The FAC will be issued by the PURCHASER only on demonstration of the technical specifications. T he w arranty shall commence only from the date of the issuance of the FAC.

- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
