General Conditions of Purchase Enquiry

1. Submission of offers: Offers, along with tender forms - and drawings, if any, - shall be duly signed and submitted in sealed covers superscribed with Enquiry / Tender No. and Due Date and the bidder's name and address. The bids shall reach us on or before the due date and time of opening of Tender. Samples, where required, shall be submitted along with the offer.
2. IREL (India) Limited reserves the right to amend in part / full any or all tenders / enquiries without assigning any reason. Bidders are advised to check the websites <http://bit.ly/mstcirelil>, <http://bit.ly/ireliltenders> and <http://bit.ly/cpppirelil> prior to submitting offer.
3. Bidders are advised to renew their registration with IREL (India) Limited, Chavara. Please visit <https://bit.ly/irevendreg>.
4. Tenders through Telex / FAX / Telegram / Email shall not be accepted, except in the case of Proprietary tender / enquiry.
5. Offer should be free from overwriting and/or erasures. All corrections and/or additions should be self-attested.
6. Unless otherwise specified in the tender / enquiry, prices shall be quoted in Indian Rupees and shall be for supplies on 'F.O.R. IREL (India) Limited, Chavara' basis as per specimen Price Schedule format given.
7. Bidder should submit price for supply/erection/services etc. separately, if required. Rates for supervisory services of bidder's personnel shall be indicated separately, for use in cases where we decide to undertake the erection / installation departmentally.
8. The rates quoted shall include all taxes, levies, etc. that are applicable. It shall clearly indicate the applicable rate / amount for each component. If nothing is specifically mentioned in the offer, it shall be construed that the rate is all inclusive.
9. Bidders are required to quote firm price, valid for a minimum of 45 days from the date of opening of the tender / enquiry.
10. Bidder shall mention the delivery period required for them to execute the order, as against the requirement of the tender.
11. IREL (India) Limited reserves the right to accept or reject in part / full any or all tenders / enquiries without assigning any reason.
12. IREL (India) Limited also reserves the right to waive, in whole or in part, any of the clauses mentioned herein.
13. Evaluation of bid: Unless provided for otherwise, technically and commercially acceptable bids shall be evaluated on Overall L₁ basis for placement of order. However, IREL (India) Limited reserves the right to evaluate offers on Individual L₁ basis and also split the order (item-wise / quantity-wise) among the bidders, if required, to IREL (India) Limited's benefit.
14. Payment terms: 100% payment shall be released within 30 days of receipt and acceptance of goods at site / IREL (India) Limited, Chavara after due inspection, acceptance and certification by the official concerned. All payments may be subject to TDS (Tax Deduction at Source) at the prevailing rates as provided in the Income Tax Act.
15. In case bidder submits payment terms other than those stipulated above, IREL (India) Limited reserves the right to reject / accept the bid. If accepted, IREL (India) Limited will load a factor @12% (Twelve) while evaluating the bid.
16. Unless provided for otherwise in the contract, payment shall be released only after completion of the entire supply.
17. Period of Contract: Time is of the essence in the contract. The time indicated in the Purchase Order is for delivery of goods at IREL (India) Limited Stores, Chavara / designated site and shall be strictly adhered to; otherwise, LD would be applicable (See Cl. 18).
18. Security Deposit (SD): As applicable to the contract, the supplier shall remit SD equivalent to 3% or 5% of the total contract value (inclusive of EMD, if any), as the case may be as per prevalent rules/conditions. This may be submitted by way of BC/DD/BG in favour of IREL (India) Limited, Chavara payable at Chavara on any scheduled bank or in any other form acceptable to IREL (India) Limited. The SD shall be *i*) forfeited in the event of non-execution / unsatisfactory execution of the order, *ii*) refunded without interest after satisfactory execution of the order.
19. Inspection and acceptance: Until certified as conforming to the P.O. on inspection at its Stores, IREL (India) Limited shall not be deemed to have accepted the goods / supplier shall not be deemed to have delivered the goods as per the P.O.
20. Liquidated Damages (LD): For delays attributable to the supplier / contractor, LD shall be levied at the rate of 0.5% per week or part thereof on the value of unfinished supplies for each week of delay, subject to a maximum of 5% or 10% of the total contract value, as the case may be as per prevalent rules/conditions.
21. Cancellation: IREL (India) Limited reserves the right to cancel the P.O., in whole or part thereof, without assigning any reason whatsoever, against 2 weeks' written notice to the supplier if they *(i)* fail to supply goods in accordance with the PO *(ii)* go bankrupt or go into liquidation *(iii)* fail to deliver the goods on time *(iv)* fail to replace the rejected items promptly to the satisfaction of IREL (India) Limited *(v)* fail to comply with any contractual requirements like timely remittance of SD and / or commit breach of any of the contractual terms and conditions *(vi)* indulge in unlawful activities and fraud.
22. In the event of cancellation of the P.O. in full or part, IREL (India) Limited reserves the right to get the balance work executed through any other agency at the risk and cost of the supplier / contractor.
23. The quantities indicated in the Tender / Enquiry are indicative and IREL is not obligated to place order for the full quantities.
24. Ordered items are to be supplied at our Stores strictly using recyclable packing materials only.
25. Vehicles making deliveries at IREL (India) Limited, Chavara shall have valid PUC Certificate.
26. Unloading at IREL (India) Limited Stores, Chavara shall be done by us and charges shall be borne by us. Incidental expenses, other than unloading charges, shall be to party's account.
27. Force Majeure: Either party shall be exempted from performance of the contract by circumstances beyond its reasonable control, which shall include, but shall not be limited to, acts of God, governmental action, war or national emergency, riot, civil commotion, fire, explosion, flood, epidemic, lock-out, strike or other labour disputes (whether or not relating to either party's workforce) or restraints or delays affecting carriers.
28. Arbitration: All disputes or differences arising out of or in consequence to the contract shall be settled by the sole arbitrator appointed by IREL (India) Limited in accordance with the provisions of the Arbitration and Conciliation Act 1996. The venue of arbitration shall be Kollam.
29. Jurisdiction: In the event of disputes, the same will be subject to exclusive jurisdiction of the Courts of Kollam, Kerala.

2. In tender, participating Micro and Small Enterprises quoting price within price band of L1+15% shall also be allowed to supply a portion of the requirement after they bring down their price to L1 price, in a situation where L1 price is from someone other than a Micro and Small Enterprise. Such Micro and Small Enterprise shall be allowed to supply at least 25% of total tendered value or as per existing MSE rules.
3. In case of more than one MSE coming in the price band of L1+15%, the quantity allotted to MSEs shall be shared in equal proportion among such MSEs, provided all of them bring down their price to L1 price.
4. Out of 25% procurement from MSEs, 4% is earmarked for MSE units owned by Scheduled Caste / Scheduled Tribe (SC/ST) entrepreneurs and 3% for women-owned enterprises. Tenderers are required to state clearly if they are SC/ST entrepreneurs or women-owned enterprises.
5. MSEs are required to submit along with their offer, Udyog Aadhaar Memorandum or valid Registration Certificate issued by NSIC / DIC / KVIC / KVIB / Coir Board / Directorate of Handicrafts and Handlooms or valid certificate issued by any other body specified by Ministry of MSME. Benefits available to MSEs will not be provided to those MSEs who submit such documents after opening of the bids. Any changes to the Public Procurement Policy of the Govt. of India as notified from time to time shall be applicable to this contract. MSEs claiming benefits available through registration with the above bodies have to clearly mention whether their offer is to be considered by IREL (India) Limited for grant of MSME benefits.
6. The above benefits available to MSE bidders shall be provided to those MSE bidders who submit Udyog Aadhaar Memorandum or certificate issued by NSIC/DIC/KVIC/KVIB/Coir Board/ Directorate of Handicrafts and Handlooms or any other body specified by Ministry of MSME and upload the same in CPP (Central Public Procurement) Portal.
7. TReDS is an electronic platform for facilitating the financing / discounting of trade receivables of Micro, Small and Medium Enterprises (MSMEs) through multiple financiers. These receivables can be due from corporates and other buyers, including Government Departments and Public Sector Undertakings (PSUs). Sellers, buyers and financiers are the participants on a TReDS platform. Only MSMEs can participate as sellers in TReDS, MSME need to register themselves in TReDS Platform. On completion of Registration, IREL reserve right to establish buyer-seller relation in TReDS Platform.
8. After delivery of material/ service completion, Sellers intending to avail bill discounting facility need to upload two copies of Invoice as per GST Rules, Bill of exchange for payable amount of bill as per payment milestone, Stores receipt voucher duly authenticated by IREL (in case of supply)/ Service acceptance letter duly authenticated by IREL (in case of service) ; IREL shall provide acceptance of Bill in the Portal based on contractual payment terms after deduction of tax deducted at source as per Income Tax act, GST Rules and imposition of Liquidated damages, if applicable. Seller shall to bear charges for bill discounting and processing fee. Seller thereafter can avail bill discounting facility from financier. Payment from IREL shall be made to such financier.
9. IREL (India) Limited is onboard with TReDS platform of M/s RXIL for facilitating Bill Discounting for MSME's.
