1. I) Original Equipment Manufacturer (OEM) or their Authorized dealers/ agents are eligible to participate in the tender. Authorised dealers/ agents are required to submit authorization letter from OEM. OEM shall furnish document & self declaration certificate to prove that they are the manufactures of similar items

II) OEM/Authorised Bidder should have supplied at least one no. of similar item of 5TPH capacity to any Mineral sands industry in OEM's name or authorised bidders name during last seven years ending August 2024.

12.SPECIAL CONDITIONS OF CONTRACT

SCOPE OF CONTRACT/WORK:

Supply of 3 nos. 5 TPH **Rare Earth Drum Magnetic Separator (REDMS)** of proven design used for mineral separation as per detailed specification terms and conditions furnished in the tender including transportation to IREL (India) Ltd. OSCOM stores on FOR Destination basis.

Unloading will be done by IREL at OSCOM stores.

Erection and commissioning of equipment shall be done by IREL at its site. The supplier shall extend supervisory support for commissioning of the equipment, if required by IREL, at no extra cost to IREL.

TIME PERIOD OF COMPLETION:

The order shall be fully executed within **03 months** from the date of placing order.

TERMS OF PAYMENT

Our payment terms are: 90% of order value shall be released on receipt and acceptance of the item at our stores and against receipt of a bank guarantee (valid for the entire warranty period and with an additional claim period of 3 months) for 10 % of the order value towards performance guarantee.

Balance 10 % shall be released after installation of machine and commissioning or within 3 months of effecting supply whichever occurs first.

Successful commissioning shall mean issuance of FINAL ACCEPTANCE CERTIFICATE (FAC) by IREL on demonstration of the performance and technical specifications.

If any bidder proposes for a payment term other than the above, IREL reserves the absolute right to accept or reject the term and decision of IREL shall be final and binding to all the parties. For evaluation of offers, loading shall be made at the rate of 12% per annum for variations in payment terms.

Payment shall be made by NEFT/RTGS.

MODE OF PAYMENT:

The payment shall be released after deducting the following:

- a) Compensation recoverable if any.
- b) LD recoverable, if any.
- c) Recoveries on account of contractee's facilities and services, if any.
- d) Deduction, if any, towards re-couplement of any amounts forfeited, adjusted, deducted out of security deposit.
- e) All Statutory deduction, if any, as per rules.
- f) Deduction as per IT Act, 1961, if any.
- g) Any other deduction related to this contract.

PREDISPATCH INSPECTION

IREL reserves to have pre-dispatch inspection of machines prior to its dispatch. Readiness for pre-dispatch inspection shall be intimated at least 15 days in advance so that IREL (INDIA) LIMITED can depute its representative and mobilize the required samples if any required. On ascertaining the performance of the machines, clearance shall be given for dispatch of the machine.

However final inspection shall be done at our stores and this only shall be the basis for final acceptance .

PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, damage or breakage during shipment/transportation, handling and storage in a tropical climate, ideally in wooden cartons. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated

MARKING ON PACKAGES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Name & Address (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference number

INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage during transportation/shipment and handling. For delivery of goods at the purchaser's premises, the insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

TRANSPORTATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM shall be done by the contractor at their risk and cost.

UNLOADING, HANDLING:

Unloading at site shall be done by IREL at its cost.

TESTING AND COMMISSIONING:

IREL will install the machine at its site within a period of 3 months from the date of delivery and shall test and Commissioning of the entire system at site. For major components, if so required by IREL, the manufacturer / supplier's trained engineer/ technician shall extend necessary technical supervisory supports during installation and commissioning at IREL.

e) List of components, spares and accessories.

f) If there are any bought-out systems and components, manuals should be provided in hardcopy and softcopy forms for the same.

g) Safety and security instruction manual should be provided.

h) Warranty certificates as applicable

LIQUIDATED DAMAGES FOR DELAY IN EXECUTION OF CONTRACT

For delays in effecting supply attributable to the contractor, liquidated damages shall be levied at the rate of @ 0.5% per week or part thereof on the unfinished value of the contract subject to a maximum of 5% of the total value of the contract. The liquidated damage will be recovered from any outstanding bills or amount due to the successful bidder.

WARRANTEE:

The materials/equipments and all accessories supplied shall be warranted against any defective material, malfunctioning or poor workmanship for a minimum period of 12 months from the date of installation and commissioning as indicated in FAC or 18 months from the date of supply, whichever is earlier.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
