- 1. 9. Warranty

- 1) <u>Technical competency:</u> a) The Bidder or its OEM {themselves or through re-seller(s)} should have supplied Electromagnetic flow meter of minimum order value Rs. 8.44 lakhs in a single / t wo order in last five years ending bid opening date to any Central / State Govt. Organization / P SU / Public Listed Company / private organizations. Copies of relevant contracts (providing sup ply of along with completion proof like tax invoice / CRAC etc to be submitted along with bid in support of quantity supplied.
- b) Party should be Original Equipment Manufacturer (OEM) or their authorised representative (Valid Authorisation letter/certificate are to be submitted along with the offer) otherwise offer shall not be considered.
- c) Party should clearly mention make, model, Sizing Sheet etc of the item quoted and submit d

etail technical literature of the same along with the offer and performance certificate. Otherwise the offer will be rejected.

d) Bidder quoting for Equivalent make shall submit performance certificate from the end user s hould be mentioned with name, designation, address, e-mail Id and Phone No etc., Otherwise th e offer will be rejected.

<u>NB:</u> a) For MSE & Start-up bidders, past experience is relaxed. However, bidders have to estable ish their technical competency by submitting supporting documents towards successful executation of similar supplies for any value, failure to which the offer will not be considered for evaluation.

b) Bidder should clearly understand the specification is available in ATC with bid and upload the same with sign & seal along with bid, otherwise offer will be rejected.

2) <u>Note:</u>

As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2 017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, t he purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be i gnored or considered further. No change in prices or substance of the bid shall be sought, offered or permit ted. No post bid clarification at the initiative of the bidder shall be entertained. The shortfall information / documents should be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergone change since then. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For example, if the bidder has submitted a supply order without its completion / performance certificate, the certificate can be asked for a nd considered. However, no new supply order should be asked for so as to qualify the bidder.

- 3) As per section 7.3.1 of Manuals for procurement of Goods, the offer shall be declared as unre sponsive and be ignored during the initial scrutiny if:

- iii) The bidder is not eligible to participate in the bid as per laid down eligibility criteria(example: the tender enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large scale unit);
