If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. SCOPE OF WORK AND TECHNICAL SPECIFICATIONS FOR SUPPLY, INSTALLATION AND RETROFIT TING OF Air Circuit Breaker (ACB)

- This scope of work is intended to cover engineering, testing, packing & forwarding, supply, delivery at M/s IREL (India) Limited – OSCOM – Central Stores, Ganjam, installation and commissioning of Electricall y operated, Draw out type Air Circuit Breakers (ACB) in place of existing old ACBs as specified hereunde r & as given in the Bill of Materials (BOM).
- The executing firm shall visit the site i.e. OSCOM MSP and get acquainted to the existing scheme of in stallation of the old Air Circuit Breakers (ACB).
- The existing old ACB installed at HUS MCC Panel Siemens make 1600 Amps, 3 Pole, EDO, Garnet plant MCC Panel – 1000 Amps, 4 Pole, C-Power, L&T make and 2M1 MCC Panel – Schneider make 1600 Amps, 4 pole; is to be retrofitted in this scheme.
- Necessary modification, for co-ordination/matching of new 415 V ACB to suit the requirements of existing breaker, Bus Bars, etc. shall be covered under the scope of this contract.
- It is also intended to include complete operational checks, tests to confirm suitability of new breaker b oth technically as well as dimensionally to existing breaker and system for adoption as well as performa nce and this will be the complete responsibility of the bidder
- The ACBs and installation shall conform to high standards of engineering design and workmanship in all respects and shall be capable of performing continuous operation in a manner acceptable to M/s IREL (In dia) Limited.
- The design aspects of the ACBs shall consider Reliability, availability and maintainability which are of utmost importance to M/s IREL (India) Limited.

SCOPE

- The scope of supply shall include but not limited to supply of Air Circuit Breakers. The supply includes 01 (one) no. of 2000 amps, 02 (two) no.s of 1600 Amps and 01 (One) no. of 1000 Amps Air Circuit Breakers as specified in Technical specification with all required accessories and fitting arrangements.
- Shifting of ACBs as per requirement from Central Stores to respective MCC panel Room or area where retrofitti ng is required to be carried out.
- The scope of supply shall include supply of wires, lugs, sleeves, connectors, screws, nut bolts, plate, aluminum bus bars, gasket, Switches, Indications/ displays to monitor breaker operation status etc. required for retrofitting and other accessories which are necessary for satisfactory operation of breaker though not individually or specifi cally mentioned herein.

In case where suitable Indian Standards are not available, generally accepted codes and practices as m utually agreed upon shall be adopted. The equipments shall comply with the statutory requirements of the Govt. of India. The equipment and installation shall conform to the provision of statutory and other regulations in force such as Indian Electricity Act etc. The successful bidder shall provide the necessary support like drawings, data etc as req uired by the statutory authorities. In cases where the offer deviates from the specified standards, the successful bidd er shall indicate clearly in his offer the standards proposed to be adopted by him and the details thereof.

2. Scope :

The scope of work includes and not limited to
