- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

3. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

1. Technical Competency:

This is a proprietary tender only OEM M/s. Mineral Technologies or their authorized representative can part icipate. However valid bid specific authorization certificate is to be submitted along with offer.

2)EMD: Bidders quoting with authorized from OEM should submit EMD. otherwise offer will be rejected.

3) Note: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurem ent of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and co mparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The r equest for clarification shall be given asking the tenderer to respond by a specified date. If the tendere r does not comply or respond by the date, his tender will be liable to be rejected. Depending on the out come, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bidder shall be ent ertained. delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
