# X) SPECIAL CONDITIONS OF CONTRACT:

1. SCOPE OF CONTRACT/WORK: The scope of supply includes and not limited to supply of 750 kVA Unitized substatio n as per detailed specification, terms and conditions furnished in the tender including transportation to OSCOM stor es on FOR Destination basis.

Unloading will be done at OSCOM - Central Stores by IREL.

Erection of equipment shall be done by IREL at its site. Required foundation drawing, electrical line diagrams, etc shall be timely provided by the supplier. Required supervisory supports shall be extended by the supplier towards erection. Commissioning shall be done by the contractor in presence of IREL

# XI). Time period of completion:

The order shall be fully supplied within 6 months from the date of acceptance of order.

XII)Terms OF Payment

90% payment along with 100% taxes and duties shall be made towards supply against tax invoice within 3 0 days of receipt & acceptance of the equipment at IREL, OSCOM Stores.

10% shall be paid after successful commissioning of the equipment against receipt of a bank guarantee valid for 12 months from the date commissioning OR 18 months from the date of supply whichever is earlier with an additional c laim period of 3 months.

The bidder has to quote terms of price FOR OSCOM unit, Matikhalo, Ganjam Dt, Odisha. The rate offered shall includ e any cost towards extending supervisory supports during installation and commissioning, if so re quired by IREL. The rate quoted shall be in Indian Rupees only.

On ascertaining the performance of the equipment's, clearance shall be given for dispatch of the equipment's.

However final inspection shall be done at IREL site and this only shall be the basis for final acceptance.

### XV. PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, damage or brea kage during shipment, handling and storage in a tropical climate, ideally in wooden cartons. All ex posed ferrous me tal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated.

### XVI. MARKING ON PACKAGES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Na me & Add ress (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference number.

#### XVII.INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage during transpo rtation/shipment and handling. For delivery of goods to the purchaser's premises, it is advised t hat insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse " (final destinations) on "All Risks" basis including War Risks and Strikes.

### XVIII.TRANSPORTATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM, Matikhalo shall be done by the contractor at their ri sk and cost.

### XVIII. UNLOADING, HANDLING:

Unloading at site shall be done by IREL at its cost. Any incidental expenses at IREL other than unloading charges shall be borne by the supplier Procedure for unloading and handling shall be communicated by the supplier to IREL well in advance.

# XIX. INSPECTION:

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your representative for ca rrying out joint inspection at site or else IREL may conduct inspection on its own. If it is found that any item does not conform to the specification given, or is defective in any manner, the same will be rejected and supplier should arra nge for immediate replacement thereof, free of cost to us inclusive of all taxes and duties. Such replacement suppli es will also be subjected to our inspection as above before acceptance. However, such supplies, if delayed beyond the period of contract will be considered as late supply and will attract Liquidated damages.

### XX) INSTALLATION /ERECTION:

The equipment shall be installed/erected by IREL at its cost. Procedure for handling/erection/installation shall be clea rly communicated by the contractor. This shall include timely intimation of foundation drawings and details, power a nd other electrical connection details, et c to be provided to IREL. If so, required by IR EL, the contractor shall exten d necessary supervisory supports for erection/installation at no extra cost to I REL.

### XXI) TESTING AND COMMISSIOING:

Installation of 750 kVA unitized substation will be carryout out by IREL. If so required by IREL, the manufacturer's / s upplier's trained engineer/ technician shall extend necessary technical supervisory supports during installation.

Any special commissioning spares, tools, tackles required shall be provided by the supplier.

Commissioning of 750 kVA unitized substation shall be carried out by the contractor at IREL.

### XII)TRAINING:

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
