- 1. 2.0 Earnest Money Deposit (EMD)

- 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- **2.5** Offers without EMD or valid EMD exemption certificate shall not be considered.
- **2.6** The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his quotation subs equent to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and a pproval. MSME /SSI units are exempted from payment of EMD/ TDC provided they submit v alid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains t o the class of item/works for which floated.

3.0 SECURITY DEPOSIT (SD),

- 3.1. Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) tow ards satisfactory completion of the order/works as under:
 - a. For works contract valued more than Rs.2 lakhs.

- b. For supply & service contract valued more than Rs.5 lakhs.
 - Performance Security is to be furnished by a specified date (generally 14 (fourteen) days af ter notification of the award) and it should remain valid for a period of 60 (sixty) days beyon d the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).
- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety B onds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender in viting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalised Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.

4. Payment Terms

1. The payment for the transportation work will be made within 30 days by IREL (India) Ltd., O SCOM after delivery of Monazite cargo at destination against your bills for each load duly certified by our company officials, subject to deduction of tax at source as applicable. Applicable G.S.T will be paid directly to the Government by IREL(India)Ltd. Hence no G.S.T shall be paid by the contract or.

All payment are subject to deduction of tax at source as applicable.

GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CGST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UTGST act 2017.

Our GSTIN 33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.

All the payment will be done only through e-payment. Hence, you have to provide your name, ac count no., name of the bank, and nature of account (savings/current/CC/OD), IFSC, branch code an d cancelled check along with invoice.

5. LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s)specified in the C ONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the C ONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten per cent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling du e to the Service Provider or by recovery against the Performance Guarantee. Both Service Provi der and EMPLOYER agree that the above percentages of price reduction are genuine pre-estima tes of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

6. **Completion Period:** Within12 months from the date of start of work order or transportation

of 1800 MT of Monazite from IREL, Manavalakurichi to IREL OSCOM whichever is earlier. It is o pen to IREL to terminate the contract without assigning any reason or reasons by giving two w eeks notice and no claim for any loss or damage or compensation for such terminations of contract shall be payable by IREL or maintainable against IREL. Firms, companies or other bod y corparates, submitting the tender should attach with the tender a duly certified copy of the a uthority of the person signing the tender to bind the firm, Company or body corporate as the c ase may be for fulfilling the contract.

If the performance of the contractor is found unsatisfactory, the contract is liable to be termina ted on 15 days notice by us. If there is breach of all or any of the terms of the contract we may , at our sole discretion, revoke the contract and forfeit the security amount deposited by the contractor and also proceed against the contractor for recovery of such loss or damage as we may sustain as a result of such breach on the contractor's part. Company will not guarantee for a ny quantity within the period of contract. However contractor shall be bound to undertake less er quantity or excess quantity during the above contract period on the same rate, terms and conditions.

- 7. **Period of Contract:** The period of contract is one year from the date of start of work. If the entire quantity could not be transported within one year from the date of start of work due to r easons attributed to IREL, the period of contact can be further extended for a maximum period of another one year for the balance quantity on mutually agreeable basis of IREL and the successful bidder. The work is to be started within 3 days from the date of intimation receive d from IREL. It is open to IREL to terminate the contract without assigning any reason or reasons by giving two weeks notice and no claim for any loss or damage or compensation for such the erminations of contract shall be payable by IREL or maintainable against IREL.
- 8. In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall govern.
- 9. In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipul ated by IREL shall govern.
- 10. MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.
