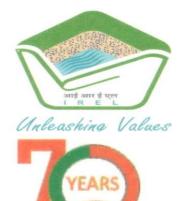

GENERAL INSTRUCTIONS TO BIDDERS

1.0 GENERAL

- 1.1 Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 1.2 Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 1.3 Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

2.0 PREPARATION AND SUBMISSION OF BIDS

- 2.1 The tender bids duly filled in all aspects and uploaded at GEM Portal on or before the scheduled time and date as mentioned in the tender enquiry will be considered for evaluation.
- 2.2 Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e., on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2.3 The Bids shall be prepared in two parts viz. PQ cum Technical Bid (Part-I) and Price Bid (Part-II). The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 2.4 Technical Bid will be opened at the first instance and evaluated by IREL's concerned authority. In the second stage, financial bids of only the technically eligible offers will be opened for further evaluation and ranking before awarding the contract.

PQ cum Techno-commercial bid (Part -I)

It contains documents in support of eligibility criteria, self-attested tender document and any other document specifically specified in this tender document.

Part -II shall contain Price Bid (to be submitted electronically).

This part shall contain only Schedule of prices duly filled in as per the Bid Proposal Schedules. No physical submission of hard copy is permitted.

2.5 The uploaded tender documents become readable only after the tender opening by the authorized bid openers.

3.0 METHOD OF SELECTION:

Part-I of the bid will be evaluated and bidders meeting the PQ criteria and other tender conditions will be qualified as eligible bidders for opening of the price bids. The price bids opened subsequently will be scrutinized for responsiveness and IREL shall consider placement of order on the qualified bidder, whose offer shall be overall lowest. However, IREL reserves the right to accept or reject all or any tender without assigning any reasons and does not bind itself to accept the lowest offer.

7.0 RETENTION MONEY

- 7.1 Where in a contract, payment is made on progressive billing of work executed, 5% of the bill value shall be retained at the time of making payment towards rectification/defective work made a s retention money.
- 7.2 The total retention money together towards performance guarantee shall not exceed 10% of the contract value.

8.0 REFUND OF RETENTION MONEY

- 8.1 Before releasing retention money in respect of supplies/works, a "No Due Certificate" shall be issued by EIC/OIC duly countersigned by head of the department after ensuring that no amounts are recoverable from the supplier/contractor.

PRE-QUALFICATION CRITERIA (PQC)

- 1.0 The bidder must be OEM or Authorized service dealer for Lauritz Knudsen (formerly L&T) make circuit breakers.
- 2.0 In case of service dealer, valid authorization certificate from the OEM shall be provided along with the technical bid.

SPECIAL CONDITIONS OF CONTRACT (SCOC)

1.0 **SCOPE OF WORK:**

Maintenance contract for Lauritz Knudsen (formerly L&T) make ACBs/Bus Coupler and testing/calibration of relays of ACBs includes but not limited to the following activities:-

4. SITE INSPECTION:

Interested bidders can inspect the site on any working day between 10.00 to 15.00 hours from Monday to Friday at RED, Udyogamandal.

5. SCOPE OF IRE:

Electric power, water, electrical/mechanical work shop facility (subjected to its availability) will be given by the company on free of cost.

6. SCOPE OF CONTRACTOR:

- 6.1 All the spares as mentioned in the bill of quantites.
- 6.2 The Material/instruments/tool required for the completion of work shall be under the scope of contractor.
- 6.3 The price quoted shall include the cost of material supplied by the contractor.

7. **WORKING TIME:**

The normal time of work is between 0800Hrs to 1600 Hrs on any working day. The contractor may be allowed to work extra time as and when required but it should not exceed more than 1800Hrs with prior intimation and approval of Engineer-in-charge. The contractor has to take work necessary safety permit from the safety department before starting the work.

8. COMMENCEMENT AND COMPLETION OF WORK:

- 8.1 Work shall be carried without affecting the normal operation of other plants. Qualified supervisor shall be present for supervising the work.
- 8.2 Work shall be commenced within 7 days from the acceptance of the work order or 7 days from the date handing over the site whichever is later.
- 8.3 The entire work as specified in the work order shall be completed within 60 from the date of order. In case of any stoppage of work by IREL after commencement of work, the number of days stopped shall be extended for the completion of work. Provided due record of the same should be available duly accepted by EIC.

9. <u>RATE:</u>

- 9.1 The quantity mentioned in the price schedule is approximate.
- 9.2 The payment will paid for actual quantity of work carried out.
- 9.3 Rate should be quoted including the cost of material supplied by the contractor as per bill of material/price schedule.
- 9.4 Contractors shall advised to quote for entire work as per price schedule
- 9.5 Partial quote/incomplete quote shall not be considered for L1 status.

10. PAYMENT:

- 10.1 Payment will be based on the actual quantity of work completed against the quantity mentioned.
- 10.2 The payment will be only after the completion of the entire work. Part payment shall not be entertained at any circumstance
- 10.3 payment shall be released within 30 days from the date of submission of neat and clear invoice with the recommendation of EIC.
- 10.4 The contractor is responsible and liable to remit all statutory dues collected/included in the Price Schedule of the contract, to the Statutory Authorities without fail. IREL is not responsible for remittance of such tax collections.

11. SAFETY & HOUSEKEEPING:

It is the sole responsibility of contractor to carry out the work in an utmost safe manner. Successful contractor will have to carry out the work as per the rules laid down by IREL Safety department. The debris generated during the course of erection needs to be cleared then and there and the work spot shall be kept clean. If such waste is not removed, the expenses incurred for the waste removal will be deducted from the contractor bill amount

12. **GUARANTEE**:

All Activity in connection with work has to be carried out in consultation with Engineer Incharge of company, without affecting company's normal operations. Servicing, testing/calibration of ACBs/Bus Coupler work is to be guaranteed for a minimum period of 12 months from the date of completion of work against any defective workmanship.

DEFINITIONS & INTERPRETATIONS

SECTION - I

1.1 Definition of Terms:

In this Contract (as defined here-in-after), save where the context otherwise requires, the following words and expressions shall have the meanings respectively assigned to them.

"Approved" means approval in writing including subsequent written confirmation of previous verbal approval(s).

The "Bid /Tender/Offer" means the proposal along with required supporting documents submitted by the Bidder/Service Provider for consideration by the Employer

The 'Bidder/Tenderer' means the person(s) / Firm / company /Corporation /Organization/entity,who participated in the Tender.

"Completion Certificate" means the certificate to be issued by the Engineer In-charge (EIC) when the Services have been completed entirely in accordance with Contract.

"Completion Date" means the date of actual completion of the services by the Service Provider as certified by the Employer.

'Contract' means an agreement between Employer and the Service Provider/Supplier for execution of the Service(s) as per Contract Documents and its subsequent amendment(s), if any in writing thereto.

"Contract Documents" means collectively the Tender Documents, Designs, Drawings, Scope of Services, Specifications, Schedule of Rates (SOR), Letter of Acceptance and agreed variations if any, and such other documents constituting the tender and acceptance thereof.

"Day" means a calendar day of 24 hours from midnight to midnight irrespective of the number of hours serviced in that day.

"Demobilization" means removal of all equipment, machinery, manpower from the site after completion of the services with the due permission of EIC.

"Drawings" means and include all Engineering sketches, general arrangements/ layout drawings, sectional plans, all elevations, etc. related to the Contract together with modification and revision the
