- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific Scope Of Work(SOW)

Scope of Work

- 1. Rubber lining is to be done on the inside surface of Conditioner tank (2 nos.)
- 2. Supply of rubber sheet with vulcanisation solution is under bidder's scope.
- 3. Total thickness of rubber lining has to be 10 mm, either single ply of 10 mm or 2 ply of 5 mm may be used to achieve the total thickness of 10mm.
- 4. Rubber sheet shore A hardness will be in the range of 50 to 60. Material test certifica te is to be provided along with supply of material
- 5. Rubber lining is to be done with hot process only.
- 6. Surface preparation is under the bidder's scope.
- 7. For hot process, all the tools and tackles will be under bidder's scope except supply of steam that will be given by IREL.
- 8. All requisite manpower, necessary scaffolding, safety compliances, consumables, too ls and tackles including hydra etc. is to be arranged by successful bidder.
- 9. Work should be done with utmost care as in the case of any damage to machine equi pment's, party will be held responsible and will be penalised accordingly.
- 10. IREL will give only 230V AC supply at single point.
- 11. Persons should use personnel protective equipment's like safety belts, safety shoes, goggles etc. and these PPE's should be arranged by the party.
- 12. Personnel who will work at site should have comprehensive personal insurance till completion of job and insurance will be arranged by the party.
- 13. IREL cannot give any room to keep material etc. and the party should arrange room for the purpose.
- 14. The party should adhere to safety norms administrative norms, commercial norms of IREL.
- 15. The contractor may inspect site before submitting the offer.
- 16. Required manpower along with qualified supervisor is to be engaged by the contract or.

- 17. Completion time: 60 days from the date of placement of order.
- 18. Inspection: Measurement shall be taken jointly and stage wise inspection will be don e by EIC.

The offers of the bidders who have defaulted in the past in execution of the contracts or in complying with the obligations as per the contract of IREL(India)Limited shall not be considered.

2) Note: As per para **7.3.5** on (Clarification of Bids/Shortfall Documents) of the Manual for Procurem ent of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tendere

r does not comply or respond by the date, his tender will be liable to be rejected. Depending on the out come, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bidder shall be ent ertained. The shortfall information / documents should be sought only in case of historical d ocuments which pre-existed at the time of the tender opening and which have not undergo ne change since then. So far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For example, if the bidder has submitted a supply order without its completion / performance certificate, the certificate can be asked for and considered. However, no new supply order should be asked for so as to qualify the bidder.

- iii. The bidder is not eligible to participate in the bid as per laid down eligibility criteria(example: the te nder enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large scale unit);
- iv. The tenderer has quoted for goods manufactured by a different firm without the required authority I etter from the proposed manufacturer.
- v. The bid departs from the essential requirements specified in the bidding document (for example, the tenderer has not agreed to give the required performance security); or
- vi. Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quoted for the entire requirement as specified in that schedule (example: in a schedule, it has been stipulated tha t the tenderer will supply the equipment, install and commission it and also train the purchaser's operat ors for operating the equipment. - 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to

such representations.
