1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Generic

The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not co mply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tend ers are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. No post bid clarification at the initiative of the bidder shall be entertained. The short fall information / documents should be sought only in case of historical documents which pre-existed at the time of the tender opening and which have not undergone change since then. S o far as the submission of documents is concerned with regard to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. b) The required EMD has not been provided or exemption from EMD is claimed without acceptable proof of exemption;

c) The bidder is not eligible to participate in the bid as per laid down eligibility criteria (example: the tender enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large sc ale unit); d) The tenderer has quoted for goods manufactured by a different firm without the required authority lette r from the proposed manufacturer.

e) The bid departs from the essential requirements specified in the bidding document (for example, the te nderer has not agreed to give the required performance security); or

f) Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quoted for the entire requirement as specified in that schedule (example: in a schedule, it has been stipulated that the te nderer will supply the equipment, install and commission it and also train the purchaser's operators for op erating the equipment. If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed deli very period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damag es for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as p re-estimated damages not exceeding 5% of the total contract value without any controversy/dispute of an y sort whatsoever. However, in case of inordinate delay maximum deduction shall be 10% of the total cont ract value.

Note: Inexcusable delays of more than one-fourth (25%) of the completion period specified in the contract shall be treated as inordinate delay(s).

NDITIONS OF CONTRACT

1. SCOPE OF CONTRACT/WORK:

The scope of supply includes and not limited to supply of one screw air compressor as per detailed specific ation, terms and conditions furnished in the tender including transportation to OSCOM stores on FOR Desti nation basis. The supplies include control panel, required pressure, temperature gauges, etc (air receiver/ air drier not included).

Unloading will be done at OSCOM stores by IREL

Erection of equipment shall be done by IREL at its site. Required foundation drawing, electrical line diagra ms, etc shall be timely provided by the supplier. Required supervisory supports shall be extended, if requir ed by IREL towards erection. Commissioning shall be done by the contractor in presence of IREL

2.Time period of completion:

The order shall be fully supplied within 12 weeks from the date of placement of order. Foundation drawing and necessary electrical connection details shall be provided within 4 weeks of placement of order.

It is suggested that the contractor shall provide necessary input to IREL in proper placement of the compre ssor in IREL's plant and if so required they shall visit IREL's site to assess the ground situation for this.

3.Terms OF PAYMENT

a. 80% payment along with 100% taxes and duties shall be made towards supply against tax invoice withi n 4 weeks of receipt & acceptance of the equipment at IREL, OSCOM Stores.

b. 20% shall be paid after successful commissioning of the equipment issue of Final Acceptance Certificate (FAC) or within 12 weeks of supply whichever is earlier and against receipt of a bank guarantee valid for 1 2 months from the date commissioning OR 18 months from the date of supply whichever is earlier with an additional claim period of 3 months.

c. The bidder has to quote terms of price FOR OSCOM unit, Matikhalo, Ganjam Dt, Odisha. The rate offered shall include any cost towards extending supervisory supports during installation and commissioning, if so, required by IREL. The rate quoted shall be in Indian Rupees only.

If any bidder proposes for a payment term other than the above, IREL reserves the absolute right to accept

or reject the term and decision of IREL shall be final and binding to all the parties. For evaluation of offers, l oading shall be made at the rate of 12% per annum for variations in payment terms.

4. MODE OF PAYMENT:

The payment shall be released after deducting the following:

· Compensation recoverable if any.

- · LD recoverable, if any.
- · Recoveries on account of contractee's facilities and services, if any.

 \cdot Deduction, if any, towards re-coupment of any amounts forfeited, adjusted, deducted out of security depo sit.

- \cdot All Statutory deduction, if any, as per rules.
- · Deduction as per IT Act, 1961, if any.
- \cdot Any other deduction related to this contract.

5. PREDISPATCH INSPECTION

IREL reserves to have pre-dispatch inspection of machines prior to its dispatch. Readiness for pre-dispatch inspection shall be intimated at least 15 days in advance so that IREL (India) Limited can depute its repres entative and mobilize the required samples for carrying out trial, if any required. On ascertaining the performance of the machines, clearance shall be given for dispatch of the machine.

However final inspection shall be done at our stores and this only shall be the basis for final acceptance.

6. PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, damag e or breakage during shipment, handling and storage in a tropical climate, ideally in wooden cartons. All ex posed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated

7.MARKING ON PACKAES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Na me & Address (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference number

8. INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage duri ng transportation/shipment and handling. For delivery of goods to the purchaser's premises, it is advised t hat insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods fro m "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

9.TRANSPORATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM, Matikhalo shall be done by the contractor at their risk and cost.

10. UNLOADING, HANDLING:

Unloading at site shall be done by IREL at its cost.

Any incidental expenses at IREL other than unloading charges shall be borne by the supplier

Procedure for unloading and handling shall be communicated by the supplier to IREL well in advance.
