## XII) SPECIAL CONDITIONS OF CONTRACT:

### 1. SCOPE OF CONTRACT/WORK:

The scope of supply includes and not limited to supply of the following as per detailed specification, terms and conditions furnished in the tender including transportation to OSCOM stores on FOR Destination basis.

a. Banks of Gravity Spiral Separator/Concentrators- Bank of 4, twin start 7 turn spiral suitable for Heavy Mineral sand application of proven design along with accessories. (Each set will come with One nos. of bottom entry distributor and launders to collect products separately for concentrate, middling and tailings) – 4 such banks

b. Banks of Gravity Spiral Separator/Concentrators- Bank of 2, twin start 7 turn spiral suitable for Heavy Mineral sand application of proven design along with accessories. (Each set will come with one nos. of bottom or top entry distributor and launders to collect products separately for concentrate, middling and tailings) – 1 such bank

Unloading will be done at OSCOM stores by IREL

Erection and commissioning of equipment shall be done by IREL at its site.

### 2. Time period of completion:

The order shall be fully supplied within 36 weeks from the date of acceptance of GA drawing. GA drawings shall be submitted within 7 days of release of order.

### 3. Terms OF PAYMENT

a. 80% payment along with 100% taxes and duties shall be made towards supply against tax invoice within 30 days of receipt & acceptance of the equipment at IREL, OSCOM Stores.

b. 20% payment shall be made on satisfactory commissioning (Installation shall be done by IREL. Refer to relevant clauses under Testing and Commissioning) and demonstration of performance of the equipment or within 8 weeks of receipt of item at our stores, whichever occurs first and submission of performance B G/ePBG valid for the entire warranty period as defined in the tender. The PBG /e PBG should have an additional claim period of 3 months.

### 5.0 PREDISPATCH INSPECTION

IREL reserves to have pre-dispatch inspection of machines prior to its dispatch. Readiness for pre-dispatch inspection shall be intimated at least 15 days in advance so that IREL (India) Limited can depute its representative and mobilize the required samples for carrying out trial, if any required. On ascertaining the performance of the machines, clearance shall be given for dispatch of the machine.

However final inspection shall be done at our stores and this only shall be the basis for final acceptance.

#### 6.0 PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, damage or breakage during shipment, handling and storage in a tropical climate, ideally in wooden cartons. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated

#### 8.0 INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage during transportation/shipment and handling. For delivery of goods to the purchaser's premises, it is advised that insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

#### 9.0 TRANSPORTATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM, Matikhalo shall be done by the contractor at their risk and cost.

#### 10.0 UNLOADING, HANDLING:
