- 1. Organization / PSU / Public Listed Company / private organizations. Cop ies of relevant orders along with completion proof like tax invoice / CRAC etc to be submitted along with bid in support of quantity supplied.
- b) Party should be Original Equipment Manufacturer (OEM) or their authorised representative (Valid Authorisation letter/ certificate are to be submitted along with the offer) otherwise offer shall not be considered.
- c) Bidder quoted Equivalent make shall submit performance certificate from the end user. The performance certificate should be mentioned with name, designation, address, e-mail Id and Ph one No etc., offer without performance certificate will be treated as unresponsive and will be r ejected.

NB: For MSE & Start-up bidders, past experience is relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar supplies for any value, failure to which the offer will not be considered for evaluation

### 2) <u>Note:</u>
