

DEMAND REGISTRATION BY FOREIGN BUYERS FOR GARNET PRODUCED BY IREL'S OSCOM UNIT FOR THE PERIOD APRIL TO JUNE 2024

1. IREL invites foreign buyers to register their demand for following grades of Garnets being produced by its OSCOM unit in Odisha State in India:
 - a. Garnet Coarse Grade
 - b. Garnet Medium Grade
 - c. Garnet Ultra Fine
2. Foreign buyers to register their demand for these products for lifting/ supply as monthly / staggered basis. In case of staggered basis, period of staggering like along with scheduled month of shipment is to be mentioned.
3. Interested foreign buyers are to indicate product-wise demand latest by **10TH MARCH 2024** by e-mail in the format for registering the demand given at Annexure – 1A along with details of where it will be consumed. The same shall be filled up and should be signed by the Authorized Signatory along with Seal of the Company.
4. E-mail should be sent to contactus@irel.co.in with **SUBJECT** as “**DEMAND REGISTRATION FOR GARNET – APRIL TO JUNE 2024**”.
5. Demand registration will be closed by 10TH March 2024, 24:00 hrs IST. For requests received after the scheduled time, IREL reserves the right to not consider such request.
6. Break up of quantity, where it will be consumed and schedules for shipment in case of staggered lifting are required to be mentioned in the format at Annexure – 1A. In the absence of the same, IREL reserves the right to not to consider such request for registration of demand and / or market.
7. In case the demand aggregated exceeds quantity that can be offered based on the statutory clearances, priority will be given to existing customers for sustainable supply.
8. IREL reserves the right to call for further documents, if any, to verify credentials of the buyers.
9. Mere registration of demand by customer/prospective customer does not entail any rights to the material from IREL.
10. Companies/concerns having conflict of interest in any manner with IREL in field of mining or having ongoing legal disputes with IREL are not eligible for the demand registration scheme. Also, associate/subsidiary companies or companies related in any manner to such entities are not eligible for the demand registration scheme.
11. Any dispute arising out of the interpretation of the Demand Registration process, decision of Director (Marketing), IREL shall be final and binding on all the parties. By registering the demand against the aforementioned, all parties agree to this dispute resolution mechanism.
