GENERAL INSTRUCTIONS TO BIDDERS

GENERAL

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

PREPARATION AND SUBMISSION OF BIDS

- 1) The tender bids duly filled in all aspects and uploaded at GEM Portal on or before the scheduled time and date as mentioned in the tender enquiry will be considered for evaluation.
- 2) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e., on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 3) The Bids shall be prepared in two parts viz. PQ cum Technical Bid (Part-I) and Price Bid (Part-II). The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 4) Technical Bid will be opened at the first instance and evaluated by IREL's concerned authority. In the second stage, financial bids of only the technically eligible offers will be opened for further evaluation and ranking before awarding the contract.

PQ cum Techno-commercial bid (Part -I)

It contains documents in support of eligibility criteria, self-attested tender document and any other document specifically specified in this tender document.

Part -II shall contain Price Bid (to be submitted electronically).

This part shall contain only Schedule of prices duly filled in as per the Bid Proposal Schedules. No physical submission of hard copy is permitted.

- 5) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 6) **METHOD OF SELECTION:**

Part-I of the bid will be evaluated and bidders meeting the PQ criteria and other tender conditions will be qualified as eligible bidders for opening of the price bids. The price bids opened subsequently will be scrutinized for responsiveness and IREL shall consider placement of order on the qualified bidder,

whose offer shall be overall lowest. However, IREL reserves the right to accept or reject all or any tender without assigning any reasons and does not bind itself to accept the lowest offer.

Note: To assist in the examination of documents submitted by the bidder in support of eligibility criteria (PQ), IREL may, at its discretion, ask the Bidder for clarification of its bid. The request for clarification and the response shall be in writing and no change in the price or substance of the bid shall be sought, offered or permitted.

7) **SPECIAL TERMS AND CONDITIONS**

7.1 **SITE VISIT:**

Prior to quoting rates, the bidders shall visit the site on any working days at our specified visiting hours with the permission of Engineer concerned /Purchase Dept. The bidders are also advised to study the labour supply/availability, trade union practices and labour rates prevailing at Udyogamandal.

7.2 **EFFECT AND VALIDITY OF BID:**

- (i) The submission of any bid connected with these documents and specifications shall constitute an agreement that the bidder shall have no cause of action or claim against IREL for rejection of his bid.
- (ii) The bid shall be valid for a period of 90 days from bid due date.

7.3 **RIGHT TO REJECT THE TENDER:**

- (a) IREL reserves the right to reject any tenders whatsoever without assigning any reason thereof.
- (b) IREL reserves the right to modify/ add/ reduce the scope, either in whole or in part any of the clauses mentioned herein without assigning any reason thereof.
- (c) Further IREL, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time to;
 - i. suspend and/ or cancel the Bidding Process and/ or amend and/ or supplement the Bidding Process or modify the dates or other terms and conditions relating thereto;
 - ii. consult with any Bidder in order to receive clarification or further information;
 - iii. pre-qualify or not to pre-qualify any Bidder and/ or to consult with any Bidder in order to receive clarification or further information;

7.4. **PRICES:**

Tenders offering firm prices are only acceptable to us. Firm Price shall be quoted as per the price schedule document for delivery at designated works. GST as applicable is to be considered as per the Price Schedule of the tender.

7.5. **TENDER RATES:**

- a) The rates quoted in the price schedule shall be in Indian rupees only. The quoted rates shall be firm throughout the period of Contract including extension of time, if any.
- b) If the bidder submits abnormally low bid in combination with other elements of the bid which raises material concern as to the capability of the bidder to perform the contract at the offered price, the bidder shall be asked to provide detailed price analysis of the bid in relation to the scope, schedule allocation of risk and responsibilities and any other requirements of the bid documents. If the bidder fails to demonstrate its capability to deliver the contract at the offered price the price bid shall be considered un-responsive.

7.6 Vendor should be responsible for clearing the waste materials generated during installation work.

7.7. The Bidder must quote all the products as per the Tender. Partial Bids will be rejected.

7.8 Organization is the final authority to judge the tender called items and has every power - to accept or reject the same without assigning any reasons

7.9.1 **GUIDELINES FOR PROCUREMENT FROM MSEs**

1.0 Procurement from Micro, Small and Medium Enterprises (MSEs):

The Procurement Policy for Micro and Small Enterprises, 2012 [as amended time to time] has been notified by the Government in exercise of the powers conferred in Section 11 of the Micro, Small and Medium Enterprises Development (MSMED) Act, 2006. In line with Government Policy, the prevailing guidelines in this regard as issued from time to time is to be strictly adhered to.

2.0 As per the Government notified Public Procurement Policy for Micro & Small Enterprises (MSE), it is mandated that 25% of procurement of annual requirement of goods and services will be sourced from the Micro and Small Enterprises.

3.0 In tender, participating Micro and Small Enterprises (MSE) quoting price within price band of L1+15 (fifteen) per cent shall also be allowed to supply a portion of requirement by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE and such MSE shall be allowed to supply up to 25(twenty-five) per cent of total tendered value. The 25(twenty - five) per cent quantity is to be distributed proportionately among these bidders, in case there are more than one MSEs within such price band.

4.0 Within this 25% (Twenty Five Percent) quantity, a purchase preference of four (4) per cent s reserved for MSEs owned by Scheduled Caste (SC)/ Scheduled Tribe (ST) entrepreneurs and three (3) percent is reserved for MSEs owned by women entrepreneur (if they participate in the tender process and match the L1 price).However, in event of failure of such MSEs to participate in tender process or meet tender requirements and L1 price, four percent sub-target for procurement earmarked for MSEs owned by SC/ST entrepreneurs and three (3) percent earmarked to women entrepreneur will be met from other MSEs.

5.0 MSEs would be treated as owned by SC/ ST entrepreneurs:

- a) In case of proprietary MSE, proprietor(s) shall be SC /ST;
- b) In case of partnership MSE, the SC/ ST partners shall be holding at least 51% (fifty-one percent) shares in the unit;
- c) In case of Private Limited Companies, at least 51% (fifty-one percent) share shall be held by SC/ ST promoters.

6.0 If subcontract is given to MSEs, it will be considered as procurement from MSEs.

- 7.0 In case of tender item cannot be split or divided, etc. the MSE quoting a price within the band L1+15% may be awarded for full/ complete supply of total tendered value to MSE, considering the spirit of the Policy for enhancing Govt. Procurement from MSEs.
- 8.0 Where any Aggregator has been appointed by the Ministry of MSME, themselves quote on behalf of some MSE units, such offers will be considered as offers from MSE units and all such facilities would be extended to these also.
- 9.0 **Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the policy.**
- 10.0 To reduce transaction cost of doing business, Micro and Small Enterprises is to be facilitated by providing them tender sets free of cost, exempting Micro and Small Enterprises from payment of Earnest Money (EMD), adopting e-procurement to bring in transparency in tendering process. However, exemption from paying Performance Security / Performance Bank Guarantee is not covered under the Public Procurement policy.
- 11.0 Payment to the MSME vendors is to be made within 30 days from the date of receipt and acceptance of goods/ services.
- 12.0 In case Bidder is a Micro or Small Enterprise under the Micro, Small and Medium Enterprises Development Act, 2006, the Bidder is to be asked for submitting the following along with tender: Ministry of MSME has notified criteria for classifying the enterprises as Micro, Small and Medium Enterprises as combination of investment in Plant & machinery or Equipment and Turnover. Mandatory registration in Udyam Registration Portal for all new and existing MSME has been prescribed.
- 13.0 To enhance MSME competitiveness, the Government of India envisioned the Zero Defect Zero Effect (ZED) initiative to make MSME sustainable and transform them as National and International Champions. MSME Sustainable (ZED) Certification is an extensive drive to create awareness amongst MSMEs about Zero Defect Zero Effect (ZED) practices and motivate & incentivise them for ZED Certification while also encouraging them to become MSME Champions.

The ZED (Zero Defect Zero Effect) Certification, a scheme by the Indian government for Micro, Small, and Medium Enterprises (MSMEs), offers numerous benefits, including financial incentives, improved quality and productivity, enhanced market access, and increased global competitiveness. 7.9.2 **RXIL (TReDS) PLATFORM**

7.9.3 **MAKE IN INDIA**

7.9.3.1 For this procurement, Public Procurement (Preference to Make in India). Order 2017 dated 15.06.2017, 28.05.2018 & 29.05.2019 and subsequent Orders issued by the respective Nodal Ministry shall be applicable. The bidder has to provide certificate as a proof for minimum 50% and 20% local content required for qualifying Class 1 and Class 2 Local Supplier respectively.

8.0 **RESTRICTION ON PROCUREMENT FROM A BIDDER OF A COUNTRY WHICH SHARES A LAND BORDER WITH INDIA (AS PER GOI GUIDELINES AMENDED FROM TIME TO TIME)**

The bidder to provide needful certificate attached.

9.0 IREL reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. IREL also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at contracted rates. Bidders are bound to accept the orders accordingly.

10.0 **EARNEST MONEY DEPOSIT (EMD)/ BID SECURITY**

10.1 Earnest Money Deposit (EMD) is a deposit received from the tenderers in token of their earnestness in submitting their offer to undertake the supplies/works/services/consultancy contracts and conclude a contract if entrusted to them on the basis of their tender.

10.2 EMD is to be remitted by way of 'Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt' or 'bankers cheque' or 'Bank Guarantee from any scheduled commercial Banks' or "online payment' in favour of IREL. In case of online payment, bidders should submit the UTR no. enabling verification of receipt of the amount.

10.3 Government Body/Public Sector Undertakings may be exempted from payment of EMD with the approval of Competent Authority.

10.4 EMD amount in rupee value is to be mentioned as a fixed amount in the tender and not as a percentage of the estimated cost and no interest is payable on the EMD.

10.5 EMD shall be exempted to MSEs and Start-ups as per prevailing guidelines in this regard.

10.6 EMD is liable to be forfeited if:

- a. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the date of opening/ The tenderer impairs or derogates from the tender in any respect within the period of validity of the tender
- b. The tenderer fails to accept the order when placed or fails to commence supplies/works/services after accepting the order.
- c. In case bidder submits false/fabricated documents. d) In case bidder fails to submit SD as stipulated in the tender.

10.7 The offers received from tenderers without EMD and/or tender cost shall be summarily rejected except where an exemption is provided in the tender.

10.8 EMD may be adjusted against security deposit / performance security of the successful bidder. EMD of the unsuccessful bidders should be returned to them at the earliest after expiry of the final bid validity period and latest by the 30th day after the award of the contract. Bid security should be refunded to the successful bidder on receipt of performance security. However, in case of two stage bidding/ 2or 3

envelope bidding, EMD of unsuccessful bidders during first stage i.e. technical evaluation etc. should be returned within 30 days of declaration of result of first stage i.e. technical evaluation etc.

- 10.9 In case where the EMD is provided in form of BG in the prescribed format to be attached with the tender, the BG shall be obtained from a scheduled commercial Bank with validity of 45 days beyond final bid validity period.

11.0 **SECURITY DEPOSIT (PERFORMANCE SECURITY) OR PERFORMANCE BANK GUARANTEE:**

- 11.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards satisfactory completion of the order as under:

- a) For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).

In exceptional cases waiver of SD shall be approved by Competent Authority after recording the reasons for such waiver.

- 11.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds" or „account payee demand draft" or „fixed deposit receipt from a Scheduled Commercial bank" or "Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India" or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender. In case of GTE tenders, the performance security should be in the same currency as the contract and must conform to Uniform Rules for Demand Guarantees (URDG 758) – an international convention regulating international securities. In case of JV, the BG towards performance security shall be provided by all the partners in proportion to their participation in the project. Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.

- 11.3 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/ bankers cheque is to be submitted towards SD.

- 11.4 BG format for security deposit is attached in Annexure-XIV.

- 11.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply/ work order.

Additional amount of SD due to enhancement in scope of work is also to be obtained.

12.0 **RETENTION MONEY**

- 12.1 Where in a contract, payment is made on progressive billing of work executed, 5% of the bill value shall be retained at the time of making payment towards rectification/defective work made as retention money.

- 12.2 The total SD and retention money together towards performance guarantee shall not exceed 10% of the contract value.

13.0 **REFUND OF SD AND RETENTION MONEY**

- a. Before releasing SD or retention money in respect of supplies/works, a "No Due Certificate" shall be issued by EIC/OIC duly countersigned by head of the department after ensuring that no amounts are recoverable from the supplier/contractor.

- b. EIC/OIC shall recommend release of SD and retention money after compliance by the contractor

towards guarantee/warranty/performance guarantee & other related clauses as stipulated in the purchase/work order and on submission of formal claim by contractor.

- c. On receipt of "no dues certificate" from EIC/OIC, SD or retention money retained in the form of B.G and / or any form shall be refunded at the earliest, if the contractor is not liable to pay any money to IREL (India) Limited under any other contract.

14.0 FORFEITURE OF SD & RETENTION MONEY

The SD & retention money shall stand forfeited in favor of IREL (India) Limited, without any further notice to the contractor in the following circumstances:

In case of any failure whatsoever on the part of the contractor at any time during performance of his part of the contract including the extended periods of contract, where notice is given and time for rectification allowed.

If the contractor indulges at any time in any subletting/sub -contracting of any portion of the work without approval of IREL (India) Limited.

PRE-QUALIFICATION CRITERIA (PQC)

1.0 TECHNICAL COMPETENCY

1.1 Bidder Should be experienced in having successfully executed similar works as detailed below in CPSEs / Central Govt./ State Govt./ Semi- Govt./ Private organizations during last seven (7) years ending Sep-2026 and meeting the value requirement as below.

i) One similar work order of value not less than Rs. 31.24 Lakhs Inc. GST

Or

ii) Two similar work orders of value not less than Rs. 19.52 Lakhs Inc. GST

Or

iii) Three similar work orders of value not less than Rs. 15.62 Lakhs Inc. GST

DEFINITION OF SIMILAR WORK

“Plant Operation and Maintenance contract” in any chemical industry for minimum continuous period of 1 year.

The tenderers have to furnish documentary evidence in support of the qualification criteria from concerned authority/department/organization for similar work executed like Copy of Completion / Performance Certificate / Final invoice along with copy of Work order satisfying above PQ.

The tenderer should give an undertaking in the event of getting the order, the party is capable of mobilizing the required manpower within a period of 07 days to take up the work.

2.0 FINANCIAL CAPACITY

Average Financial turn over during last three years ending March 2025 shall not be less than Rs. 11.71 Lakhs. Financial Statements / IT Returns/CA certified turnover certificate for the above periods is to be submitted. In case of Public/ Private Limited companies, published annual accounts will be accepted.

3.0 SITE VISIT CLAUSE

Site visit is mandatory for participation in this tender due to nature of work and local labour practices hence proof of site visit by owner or its representative shall be submitted by bidder along with bid documents. Without site visit proof bid will not be considered for evaluation.

SPECIAL CONDITIONS OF CONTRACT (SCOC)**1.0 SCOPE OF WORK**

The scope of work primarily involves and not limited to the following works:

Operation & Running maintenance of Utility section comprising water pump house, DM Plant, Mini Boiler, Compressors, LPG LOT Cylinder system and Firefighting system at Rare Earth Division (RED), IREL (India) Limited, Udyogamandal, Kerala. The work should be carried out by engaging qualified, competent Fitter and competent Fireman in each shift round the clock. The detail of work is given below.

2.0 DETAILS OF WORK

The party has to carry out the Operation & Running maintenance of Utility section comprising of water pump house, DM plant, Mini Boiler, Compressors, LPG LOT cylinder system and Firefighting system by engaging qualified, competent Fitter and competent Fireman in each shift round the clock. The person on duty shall perform the following operational duties:

2.1 UTILITIES SECTION

- 2.1.1 Operation of the water pumps at Pump house by switching ON/OFF the pump motors at the pump house, Opening and closing of Suction and delivery valves of the pumps at the pump house viz. Industrial water pump house, Process water pump house, Process water pump house, etc. as per the requirement for the plant operations.
- 2.1.2 Operation of the Compressors at compressor house and REP1 SFD area by switching ON/OFF the Compressors installed at compressor house, monitoring of process parameters and also checking that the required air pressure is available for different plants by regularly monitoring the airline pressure at Boiler house and draining the water from air pressure storage vessels installed at Compressor house.
- 2.1.3 Operation of Mini Boiler/Boilers at Boiler house as per the plant requirement by switching ON/OFF the Mini Boiler/Boilers as per the procedure mentioned in clause 2.3.5, monitoring of process parameters and safety parameters. Monitoring of steam line leakages, steam traps & steam temperature during operation.
- 2.1.4 Operation of DM water plant by opening the inlet water valve to DM plant & processing FACT water/Rain water at the subsequent units of DM plant as per the procedure, switching ON/OFF the pumps installed in the DM plant, maintain the required process parameter for maintaining the quality and flow of DM water, carryout the regeneration works for the DM plant as per requirement to maintain the DM water conductivity and ensuring high level DM water in all the DM tanks.
- 2.1.5 Operation of DM water pumps by switching ON/OFF the pump motors and ensuring continuous supply of DM water to the production plant. Also, ensuring the required DM water pressure is available at different plants by ensuring high level DM water in all the DM tanks.
- 2.1.6 Operation of LPG LOT Cylinder system by opening the valve of LPG line for operation of Non IBR Boiler/Other burners with LPG based on requirement. Also ensuring required LPG outlet pressure is maintained.
- 2.1.7 Monitoring the pumps, motors, pipelines, valves, water meters, tank levels, supporting structures etc. connected to utilities section to avoid any leakages, overflow, damage of equipment etc. Reporting of breakdown works of utilities section and assisting the Mechanical/Electrical/Civil persons of utilities section in carrying out the breakdown works.

2.1.8 Maintaining records/ documents of operation and running maintenance works of Pump house, Boiler house, DM plant, Compressor house and LPG LOT Cylinder system (Shift log book, log sheet, registers etc.).

2.1.9 Any miscellaneous operation related works related to utilities section, firefighting system etc. has to be carried out as per the instruction of the EIC

2.2 FIRE FIGHTING SYSTEM

2.2.1 Operation of Jockey pump/ Electrical pump/ Diesel Pump at Fire pump house by switching on/off the pump motor, opening drain valves, ensuring required water pressure is maintained at Fire hydrant system by regularly checking any leakages in any leakages in the fire line & pumps etc.

2.2.2 Operation of Fire hydrant system at different point by opening/ closing the valves, carrying out the running maintenance works by applying grease wherever required as per the schedule.

2.2.3 Operation of the Fire alarm system by switching on/off the fire alarm call points at different location and further checking at the firefighting section as per schedule.

2.2.4 Operation of the Addressable Fire alarm by manually activating the sensors at different locations if required and further checking at the firefighting section as per schedule.

2.2.5 Monitoring the different type of Fire extinguishers installed at different locations & checking that the service is carried out as per schedule, Pressure testing of the Fire hose is carried out as per schedule. Assisting the service persons in maintenance works of Fire extinguishers & Hoses.

2.2.6 Maintaining records/ documents related to Firefighting system (Shift log book, log sheet, registers etc.).

2.2.7 Monitoring the pumps, motors, pipelines, valves, water meters, tank levels etc. connected to Firefighting system to avoid any leakages, overflow, damage of equipment etc. Reporting of breakdown works of firefighting system and assisting the maintenance staff in carrying out the breakdown works.

2.2.8 Any miscellaneous operation related to utilities section, firefighting system etc. has to be carried out as per the instruction of the EIC.

The Operation and Running maintenance envisage ensuring maximum system availability, optimum usage of system, Compliance of safety rules and regulations, housekeeping, and maximum service to operating staff by maintaining continuous air supply, water supply, steam supply and firefighting system availability to the plant.

2.3 DETAILS OF UTILITIES SECTION

2.3.1 WATER PUMP HOUSE

The pump house takes care of complete water supply to Plant, Guest house and Colony Viz. Process water, Industrial water, fire fighting system, drinking water etc.

2.3.2 PROCESS WATER

2.3.2.1 The process water is collected/received from M/s FACT Ltd. Udyogamandal

2.3.2.2 The water is pumped into the overhead tank using pump, if the line pressure is below 2Kg/cm² from the overhead tank the water for process purpose is pumped to different individual plants using process pump and water for domestic purposes is given by gravity through separate line called gravity line.

2.3.2.3 The pumps and the water pipelines from the FACT input water point to the pump house has to be monitored regularly for any leakages.

2.3.3 INDUSTRIAL WATER

Water is also pumped from industrial tank/ well through two water pumps installed in the industrial pump house to three sedimentation tanks. Over flow from the sedimentation tanks are collected in the collection sump and given to fire collection tank and Effluent treatment plant based on requirement using industrial pump

2.3.4 DM PLANT

The process water received from M/s. FACT Ltd. is further treated in the DM plant to reduce the conductivity of process water below 10 micro Siemens per cm for production of DM water and is stored in DM tanks for use in production plant. The procedure for operation is as follows:

- 2.3.4.1 Initially process water is passed through Dual media filter by opening the inlet valve before Dual Media filter.
- 2.3.4.2 Pass filtered water through Strong Acid Cation unit (SAC) and allow to flow through a bed of Cation resin.
- 2.3.4.3 Pass water from SAC through Strong Base Anion (SBA) unit to flow through bed of Anion resin.
- 2.3.4.4 Pass water to the mixed bed (MB) unit to flow through a bed of Anion and Cation resins.
- 2.3.4.5 Pump the water to the DM storage tanks by operating the pump.
- 2.3.4.6 When the conductivity of the DM water increases above 10 micro mho, the DM plant (SAC, SBA and MB units) has to be regenerated using Acid and Lye simultaneously, after back washing the unit as per procedure. After regeneration, the unit is to be rinsed with water then taken to line.
- 2.3.4.7 The DM water from the DM tanks is pumped to the different plants for use in process through DM pumps (3 nos.). The pump automatically starts/trips at the set pressure. Required inlet and discharge valve has to be opened/closed for other pumps when one pump is running.

2.3.5 MINI BOILER

The Revo Max-RXD850 (Mini Boiler)/Boiler is operated as per requirement arises for plant operation. The procedure for operation and stopping is as follows:

Procedure for operation

- 2.3.5.1 Open the valve of 425 KG LPG cylinder at LPG LOT infrastructure area.
- 2.3.5.2 Open the manifold valve (A or B) of LPG line before Vaporizer.
- 2.3.5.3 Switch on the Vaporizer and as the temperature reaches 80 Deg C, open the LPG output valve after Vaporizer.
- 2.3.5.4 Open the LPG valve before burner and ensure that 1.5 Kg/Cm² LPG pressure is available.
- 2.3.5.5 Switch on the electric main panel of the Non IBR Boiler. Observe that the display comes on.
- 2.3.5.6 Close the main steam valve and open the auxiliary steam valve to prevent water entering process steam lines initially.
- 2.3.5.7 Press the FILL key on to fill up the coil. Ensure that water starts coming out the auxiliary steam valve and the unit can be fired.
- 2.3.5.8 Put the FIRE switch on. Blower and water pump will start. Sparking between burner electrodes begins, and fuel is sprayed after pre-purge timing. This pre-purging is done to drive out any combustible gases that may be present in the furnace.
- 2.3.5.9 Green lamp glows, indicating Gas Firing is ON, fuel sprays and flame is established. Sparking stops when flame is established, and heating of water in the coil starts.
- 2.3.5.10 In 3-5 minutes steam comes out of auxiliary steam valve. After pressure starts increasing, open the main steam stop valve gradually and close auxiliary steam valve simultaneously.

Procedure for stopping

- 2.3.5.11 Close the steam stop valve fully. The pressure switch will cut off the boiler.
- 2.3.5.12 Press the fire key to switch off the boiler.
- 2.3.5.13 Open the coil blow down valve fully and blow down the boiler. Close the blow down and open the auxiliary steam valve fully. Drain the economizer by keeping the drain valve open till clear water starts coming out.
- 2.3.5.14 Press the fill key and fill up the coil with water. When steam temperature indication falls below 90deg.C, press the fill key to switch off. Close the auxiliary steam valve.
- 2.3.5.15 Close the valve of 425 KG LPG cylinder at LPG LOT infrastructure area.
- 2.3.5.16 Close the LPG valve line valve before the Vaporizer.
- 2.3.5.17 Close the LPG valve after vaporizer and before Burner

2.3.6 COMPRESSOR

- 2.3.6.1 ON/ OFF of compressors installed in the compressor house based on the requirement of plant operation.
- 2.3.6.2 Taking the operational details from the control panel.
- 2.3.6.3 Removal of moisture in the compressed air by frequently removing accumulated water from the drain point of the receiver tank.
- 2.3.6.4 Thorough checking of air storage chamber & pipe lines for leaks (if any)

2.3.7 LPG LOT CYLINDER SYSTEM

The LPG LOT Cylinder system installed near lean shed to workshop is to supply LPG fuel to the Non IBR Boiler for its operation. If LPG is required for any other burner operation, the LPG LOT Cylinder system has to be operated. The procedure for starting and stopping of the LPG LOT Cylinder system is as follows:

Procedure for operation

- 2.3.7.1 Open the LPG outlet valve of 4nos of 425 Kg Cylinders of manifold A or manifold B.
- 2.3.7.2 Switch on the main to start the vaporizer.
- 2.3.7.3 Instruments and interlocks control all other functions automatically.
- 2.3.7.4 Inlet solenoid is automatically switched on when temperature reaches 60 Deg C to allow LPG liquid to flow to the vaporizer.
- 2.3.7.5 Open the inlet valve before vaporizer in controlled manner to avoid rushing of LPG liquid to the coil (abrupt opening of the valve will block the vaporizing process).
- 2.3.7.6 Open the outlet valve after vaporiser to allow LPG Vapour to PRV Station.
- 2.3.7.7 Sudden opening of this valve may result in vapour delivery line getting blocked.
- 2.3.7.8 Heater cut-off temperature is set at 80 Deg C to cut off the heating at 80 Deg C and to restart at 78 Deg C.
- 2.3.7.9 Ensure that LPG pressure is 1.5 Kg/Cm2 at the outlet of the PRV station. If the pressure is less or more than 1.5 Kg/Cm2 adjust the PRV.
- 2.3.7.10 Open the valves at the outlet line and before burner. Ensure that 1.5 Kg/Cm2 is maintained for the operation of the Non IBR.

Procedure for stopping

- 2.3.7.11 Close the LPG outlet valve of 4 nos. of 425 kg cylinders of manifold A or B.
- 2.3.7.12 Close the inlet valve before vaporizer.
- 2.3.7.13 Ensure that LPG in the vaporizers drained out and in the pipeline is consumed by non IBR boiler before closing the outlet valve.
- 2.3.7.14 Close the outlet valve after vaporizer when the pressure gauge in outlet line shows 0 kg/cm2.
- 2.3.7.15 Switch off the MAIN of the vaporizer.
- 2.3.7.16 Shutdown the non IBR boiler.

2.4 DETAILS OF FIRE FIGHTING SYSTEM

Fire fighting system consists of ground level water storage tank, pump house and Fire hydrant pipelines around the plant premises. Fire hydrants are provided at all required locations. Fire hydrant system consists of one jockey pump of 10m3/hr capacity connected to fire water lines and standby pump of electric drive high capacity pump. There are 23 Fire hydrant valves at strategic locations in factory premises. The water reservoir capacity of the system is 347m3. The jockey pump is used to maintain the fire water-network under pressure during normal operation.

There are 174 nos. of Fire extinguishers, 18 nos. of manual call points, Addressable Fire alarm system and conventional fire alarm system. The fireman also has to carry out the following works:

- 2.4.1 Perform firefighting work, including preventing, combating and extinguishing fires to protect lives, property and the environment during any fire emergency, quickly and effectively analyze hazardous situations, take appropriate course of action and give necessary feedback to the Fire officer/ in charge Fire office.

- 2.4.2 Conducting monthly inspection of each fire extinguishers, manual fire call points, Fire hydrant valves, Fire hose boxes as per the checklist available, ensuring the same is in working condition and updating the records of the fire extinguishers.
- 2.4.3 Checking and maintaining the Fire control panels & audio-visual alarms in the Fire section & various areas are in working condition and giving necessary feedback to the Fire officer/In charge Fire section.
- 2.4.4 Assisting & coordinating the AMC persons related to Fire extinguishers, Fire alarm system etc. and maintaining the records of AMC works.
- 2.4.5 Daily checking and ensuring the fire water reservoir level is maintained in full condition. Detection and attending leakages in the Fire pipelines if any in the firefighting system.
- 2.4.6 Carrying out the routine works related to Fire pump house like, starting/stopping of fire pumps, ensuring the fire hydrant system pressure is maintained, pumping of accumulated ground water in the fire pump house, monitoring of the firefighting systems, maintaining the fire buckets, maintaining of the Fire nozzles, maintain the records/registers etc.
- 2.4.7 Inspect hot work permit areas and maintain its records.
- 2.4.8 Assisting the Fire officer in Performing routine maintenance work related to firefighting system, conducting the mock drills, training, Fire programs, Fire inspections and any other works related to Fire.

2.5 RUNNING MAINTENANCE WORKS

- 2.5.1 To carry out day to day operation related running maintenance works, routine pre checks inside building of DM Plant, Compressor, Pump House, Boiler and LPG LOT Cylinder system.
- 2.5.2 Any other running maintenance works related to utilities and firefighting as per instructions of EIC.

2.6 MISCELLANEOUS WORKS

- 2.6.1 Regeneration works of DM plant (Approx. 4 times a month).
- 2.6.2 Assisting the service engineer/ EIC to carry out the cleaning /operational related maintenance works of DM Plant during the service visit/ blockage of water in any units/ any other issues related to DM Plant operation.
- 2.6.3 Removing of Pipeline & Cleaning of Foot valve of Industrial Pump during requirement.
- 2.6.4 Assisting modification works connected to utilities section during emergency requirement.
- 2.6.5 Any other emergency works related to utilities and fire fighting system instructed by EIC..

3.0 MANPOWER REQUIREMENT

- 3.1 The contractor shall engage adequate qualified persons having ITI certificate holders in Fitter/welder with suitable skilled 01 year practical experience in fitter/welder trade for Fitter category and ITI or diploma certificate holders in Fire and Safety from any recognized institution with minimum 01 year experience of working in Safety & Firefighting system for fireman category as per the following.
- 3.2 The contractor shall engage 2 persons/ shift in three shifts round the clock for operation & running maintenance of Utility section and Firefighting on all days in a month including standby persons for leave and OFF relieving duty as follows:

Fireman	Skilled	1	1	1

- 3.3 The contractor shall engage additional skilled/ unskilled persons in any day in B shift for carrying out the miscellaneous works as per clause 2.6 as per the instruction of EIC only. It is estimated that minimum 4 persons are required per month for carrying out the miscellaneous works.
- 3.4 The personnel deployed by the contractor shall have the qualification and competency as given below.

4.0 MINIMUM QUALIFICATION

4.1 FITTER

- A) The candidate should have passed 10th / 12th having knowledge of English & local language.
- B) The candidate should have passed National trade certificate from council for vocational training/ Kerala Government (Two year course) /ITI in Fitter/ Welder/ Blacksmith trade.
- C) Working experience of minimum 01 year in operation /maintenance of Pumps/ Boiler/ Water treatment plant/ compressor/structural works/valves/Pipelines etc. in any industry directly or under a contractor.

4.2 FIREMAN

- A) The candidate should have passed SSLC/10th having knowledge of English & local language.
- B) The candidate should have passed ITI or diploma or certificate course in Fire and Safety from any recognized institution.
- C) Working experience of minimum 01 year in firefighting in state fire force or in a large industrial undertaking or in any public sector undertaking or in any reputed private companies.

5.0 REQUIRED DOCUMENTS

The successful bidder shall furnish the following documents in respect of the individual manpower that will be deployed at IREL, before the commencement of work:

- (A) List of Manpower short listed by agency for deployment at IREL
- (B) Certificate of verification of antecedents of persons by the local police authority, if required, containing full details i.e. date of birth, marital status, address etc.
- (C) Bio-data of the persons.
- (D) Qualification and experience certificate.
- (E) Documents already submitted for the previous persons engaged are not required again for submission. However, any documents if required by EIC, the contractor shall submit the same.

6.0 SEX & AGE LIMIT

Since the nature of work involves working in shifts, contractor shall depute only male candidates. The age limit for the Fitter category shall be between 21- 50 years & for Fireman category shall be between 21- 55 years and should be trained, medically and physically fit.

7.0 GENERAL TERMS AND CONDITIONS

- 7.1 The contractor has to submit a list of persons with necessary certificate of the qualification and experience to be deployed for the man power stipulated to carry out the works as per the order before the commencement of contract and the same shall be verified with original certificate in person by EIC for acceptance.
- 7.2 The qualified person shall be able to read, speak and write the local language.
- 7.3 Allocation of manpower will be permitted/ approved from the list of candidature only. EIC may reject the person those who have not performed to the level of satisfaction during the contract period for which suitable replacement shall be made available by the contractor.
- 7.4 The contractor shall deploy Fitter and Fireman for each shift per day, as per clause no. 3.2 on rotation basis. (A-shift 00:00Hrs. to 08:00Hrs. B-shift 08:00Hrs to 16:00Hrs & C-shift 16:00Hrs to 24:00Hrs as presently practiced in IREL, RED). The contractor shall deploy additional persons in B shift as per clause no 3.3 for carrying out Miscellaneous works.
- 7.5 During the leave/off duty days, the contractor shall depute/substitute the absentees of man power engaged for carrying out the job. Any absent of man power in the shifts will be charged and deducted the amount as per penalty clause.
- 7.6 Contractors shall provide all standard personal protective equipment like Helmets, Gloves, Gumboots, Safety shoes, etc. required as per the safety norms.
- 7.7 The Contractor as directed by them shall arrange all safety precautions and ensure the use of personal protective equipment for all his employees.

- 7.8 Safety work permit as and when required shall be obtained from the concerned authorities before starting the specific work.
- 7.9 Based on the requirement, the deputed persons in one shift can be called to attend other shift for carrying out the emergency works based on the instruction from the EIC only. The shift of the persons engaged can be changed with the intimation of the superior official/EIC.
- 7.10 If any person employed by the contractor is found to be incompetent or found to act in an improper behavior, the matter will be brought to the notice of the contractor and the said person will have to be replaced within 72 hrs.
- 7.11 The contractor has to arrange police clearance & medical fitness in their own cost and submit the same in respective section for arranging gate pass.
- 7.12 Travelling, food and accommodation for the deployed persons shall be arranged by the contractor at their own cost. (The contractor can avail the canteen facility on payment basis subject to availability).
- 7.13 Deployed persons shall undergo training on safety & security as per statutory norms.
- 7.14 Deployed personnel shall be allowed to work for single shift only (i.e 8 hrs. duty). They may be allowed to work for next shift also subjected to the clearance from EIC. However, under no circumstances, the personnel are not allowed to work more than 16 Hrs. in a day. Being an essential duty required for plant operation, no position should be made unmanned by the contractor & the contractor should be ready with alternate reliever to man the shift.
- 7.15 The contractor shall ensure EPF, ESIC and other compensation policy for their manpower engaged.
- 7.16 If any accident / incident shall happen during the working period, the contractor shall bear all the risk & responsibility for the same as per workmen compensation act.
- 7.17 Attendance register shall be maintained by the contractor for the attendance on daily basis (for the person attending the duty) duly certified by EIC.
- 7.18 All rules and regulations existing in the company and practiced for contracts will be applicable to this contract also.
- 7.19 IREL reserve the right to terminate the contract at any time, if the performance of contract is found not satisfactory.
- 7.20 The contractor shall ensure the availability of required number of manpower to carry out the works enumerated/ as per the instruction of EIC.
- 7.21 If the salary to the person deployed is not paid, IREL have the rights to proceed further without the consent of the successful bidder including blacklisting / termination of the contract etc. whichever deemed fit.
- 7.22 The Charges quoted in the price schedule shall be firm throughout the period of Contract including extension of time, if any.
- 7.23 The contractor has to provide adequate Insurance coverage for all the staff to be deployed to carry out the works against the order for the entire duration of the contract covering all liability viz. Workmen compensation, Employers liability, etc. which are deemed to be necessary. The welfare of their staff is attributable to the contractor. IREL, RED is not responsible in case of any accident caused to their workmen during the course of their working. The contractor or their workmen cannot claim any accident relief from IREL.
- 7.24 The contractor is required to ensure that their employees comply with relevant safety requirements as mentioned in the prevailing IREL Safety policy issued upon the statutory rules and regulations laid down by the Govt. of India, depending on the nature of work.

8.0 **SCOPE OF CONTRACTOR**

- 8.1 The Contractor has to provide required workmen as per Clause 3.0
- 8.2 Contractor shall carryout only running maintenance works connected to utilities as per the following Battery Limit:

- 8.3 Tools & Tackles to carry out the running maintenance works in shift such as Spanners, Pipe wrench, hand Torch etc. to carry out the work.
- 8.4 The Contractor has to provide uniform to their persons inside IREL.
- 8.5 All Safety equipment & PPEs as per IRELS Safety regulations shall be in the scope of the Contractor.

9.0 **SCOPE OF IREL**

- 9.1 All the maintenance connected to utilities section except running maintenance of utilities section within the inside building of Boiler house, Compressor House, DM Plant, Pump House and LPG LOT Cylinder system.
- 9.2 Facilities for carrying out operation work as per the Scope of work.

10.0 **PENALTY**

The contractor envisages deployment of Fitter and Fireman in each shift with suitable relieving arrangement on OFF/ leave as per clause no 3.2. In case of absence of Fitter/ Fireman in any shift or on any day will lead to deduction as follows.

11.0 **CONTRACTORS RESPONSIBILITY**

- 11.1 Prepare written Safe Operating Procedure (SOP) for the works to be carried out, including an assessment of risk, wherever possible and safe methods to deal with it/them.
- 11.2 Provide a copy of the SOP to the person designated for the work i.e. EIC who shall be supervising the contractor's work. Keep an up to date SOP and provide a copy of changes to a person designated for the work i.e. EIC.
- 11.3 Ensure that all work is carried out in accordance with the statute and SOP and for the purpose he may deploy adequate qualified and competent personnel for the purpose of carrying out the job in a safe manner.
- 11.4 All persons deployed by the contractor for working must undergo vocational training, initial medical examination.
- 11.5 The ID cards to be issued shall state the name of the Workmen, Name of the contractor, Blood group of the workmen & its validity period indicating status of VT and IME.
- 11.6 The contractor shall designate a coordinator, out of the deployed personnel, who would be responsible for immediate interaction with EIC/ IREL officials RED, so that the services of the persons deployed by the selected agency could be availed without any disruption.
- 11.7 The contractor shall immediately provide a substitute in the event of any persons leaving the job from the site due to any reason.
- 11.8 The contractor undertakes to comply with all statues, rules, regulations and by laws as applicable.
- 11.9 The contractor has to settle the wages and dues to their workmen not less than the applicable minimum wages to the category employed as per Govt. of India guidelines.

12.0 PERIOD OF CONTRACT

- 12.1 The period of contract shall be for one year from the date of release of order. The contractor has to ensure 2 days training is to be completed before starting of the work order for the new person engaged.

13.0 PAYMENT TERMS

- 13.1 95% payment for the executed quantity less statutory deductions as applicable will be released on monthly basis within 30 days after completion of work and invoice submission duly certified by EIC.
- 13.2 5% payment against the completed work will be retained as retention money. The retention money along with 5% SD will be released after settling the final bill.

14.0 SITE INSPECTION

- 14.1 Interested bidders can inspect the site on any working days at our specified visiting hours with the permission of the Engineer concerned/Purchase Dept.
- 14.2 The bidders are advised to study the labor supply/availability, trade union practices and labor rates prevailing at Udyogamandal.

15.0 ENGINEER IN CHARGE (EIC)

Mohd Jeeshan, DM-T (Production) will be the EIC.

16.0 SECURITY DEPOSIT

Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Tax) towards satisfactory completion of order. Security deposit is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it shall remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).

SECTION - I

Definition of Terms:

"Working Day" means any Day which is not declared by the Employer to be holiday or off-day.

- iii) Fax of Acceptance

- 2.7.4 Be deemed to have satisfied himself before submitting his bid as to the correctness and sufficiency of its bid for the services required and of the rates and prices quoted, which rates and prices shall, except insofar as otherwise provided, cover all its obligations under the Contract.
- 2.7.5 Give or provide all necessary supervision during the performance of the services and as long thereafter within the warranty period/DLP as Employer may consider necessary for the proper fulfilling of Service Provider's obligations under the Contract.
- 2.7.6 Not disrupt the Services of the Employer being carried out by the Service Provider / and shall provide access for carrying out job/services to:
-Employer's personnel(s), and / or
-any other Contractor(s) / Service Provider(s) employed by Employer, and / or
-personnel of public authority(ies)/third party(ies)
- 2.7.7 Further, the Service Provider shall execute the job carefully without causing damage to the existing facility(ies) and facility(ies) of third party(ies) and in case of such happening shall immediately bring to the notice of EIC..
- 2.7.8 Further, the coordination and inspection of the day-to-day job under the Contract shall be the responsibility of the Engineer-in-Charge (EIC). The EIC or his authorized representative including any statutory authority shall at all reasonable times, have full power and authority to access and inspect the Services wherever in progress either on the Site or at the Service Provider's premises/workshops and the Service Provider shall afford or procure every facility and assistance to carry out such inspection. Such Inspection shall not release the Service Provider from any obligation under the Contract.
- 2.8 SERVICE PROVIDER'S REPRESENTATIVE & PERSONNEL:
- 2.8.1 Service Provider shall appoint a person ("*Service Provider's Representative*") who shall be responsible for and authorized to represent it at all times during the progress of the Service and to receive and to act on any request made by Employer in the performance of the Service pursuant to the terms of this Contract.
- 2.8.2 Service Provider's Representative shall have full authority to represent and bind the Service Provider in relation to any matter concerning the Service Provider's performance of the services under the Contract and Employer shall be entitled to rely on all the decisions of the Service Provider's Representative as if they were the decisions of the Service Provider.
- 2.8.3 Service Provider's Representative shall supervise, coordinate and ensure the quality of all aspects of his obligations under this Contract. Service Provider shall not change its Representative without the prior approval of Employer.
- 2.8.4 Service Provider's Representative shall liaise with Employer for the proper coordination and timely completion of the Services and on any matter pertaining to the same.
- 2.8.5 Service Provider's Representative shall extend full cooperation to Employer's representatives/inspector in the manner required by them for supervision /inspection/ observation of equipment, material, procedures, performance, reports and records pertaining to Services.
- 2.8.6 Service Provider's Representative shall have complete charge of his personnel engaged in the performance of the Service and to ensure compliance of rules and regulations and safety practice.
- 2.8.7 If the Service Provider's Representative is found not acceptable to the EIC, the Service Provider shall, as soon as practicable, having regard to the requirement of replacing him, after receiving notice of such withdrawal, remove the representative and shall not thereafter employ him again on the Services in any capacity and shall replace him by another representative acceptable to the EIC.
- 2.9 SERVICE PROVIDER'S EMPLOYEES / PERSONNEL:
- (a) The Service Provider in connection with performing the Services and remedying of any defects, shall provide:
(b) only such skilled and experienced personnel(s) in their respective areas; and
such skilled, semi-skilled and un-skilled labour as is necessary for the proper and timely fulfilling of the Service Provider's obligations under the Contract.
The Service Provider shall provide skilled / qualified / experienced personnel, if specified in the SCC /Scope of Work.
While engaging the contractual manpower, Service Provider is required to make effort to provide opportunity of employment to the people belonging to Scheduled Castes and weaker sections of society also in order to have a fair representation of these sections.
- 2.10 CONTRACT PERFORMANCE SECURITY (CPS):
- 2.10.1 The Service Provider shall provide Contract Performance Security (CPS) to the Employer, within the scheduled date specified in the notification of award for an amount mentioned therein. The CPS shall be returned/refunded three months after Contract completion period and Defects Liability Period (DLP), if any. All costs associated with CPS shall be borne by the Service Provider. No charges or interest shall be payable by the Employer even if the CPS is in the form of a Demand Draft.
- 2.10.2 If the Service Provider or their employees /agents / representatives or Sub- Service Provider (if authorized by Employer) shall damage, break, deface or destroy any property /equipment belonging to the Employer or third party(ies) during the execution of this Contract, the same shall be made good by the Service Provider at his own expenses and in default thereof, the EIC may cause the same to be made good by other agencies and recover expenses from the Service Provider. The decision of EIC in this matter shall be final and binding on the Service Provider.
- 2.10.3 All compensation, claim or other sums of money payable by the Service Provider to the Employer under terms of this Contract may be deducted from or paid by the encashment of a sufficient part of his Contract Performance Security or from any sums which may be due or may become due to the Service Provider by the Employer on any account whatsoever and in the event of his CPS being reduced by reasons of any such deductions or sale of aforesaid, the Service Provider shall within ten days thereafter make good in form of bank draft(s)/BG (as the case may be) as aforesaid any sum or sums which may have been deducted from or realised by encashment of his CPS, or any part thereof. The Service Provider shall pay to the Employer on demand without protest any balance remaining due. In this regard no interest shall be payable by the Employer to Service Provider for such sum deposited as CPS.
- 2.10.4 The CPS deposit shall cover the entire Contract value including extra jobs/ services. As long as the CPS submitted at the time of award takes care of the extra jobs/ services executed and total executed value are within the awarded Contract price, there is no need for additional CPS. As soon as the total executed value is likely to exceed the ceiling of awarded Contract Value, the Service Provider should furnish additional CPS through DD or submit amendment to existing BG to effect the enhancement of CPS.
- 2.10.5 Failure of the successful bidder to comply with the requirements of Clause 2.10 shall constitute sufficient grounds for the annulment of the award, the forfeiture of CPS and any other actions or remedies available to the Employer.
- 2.11 FAILURE BY THE SERVICE PROVIDER TO COMPLY WITH THE PROVISIONS OF THE CONTRACT:
- 2.11.1 If the Service Provider refuses or fails to provide the Service or any part thereof with such diligence as will ensure its performance within the time specified in the Contract or extension thereof or fails to perform any of his obligation under the Contract or in any manner commits a breach of any of the provisions of the Contract it shall be open to the Employer at its option by written notice to the Service Provider:
- a) TO DETERMINE THE CONTRACT in which event the Contract shall stand terminated and shall cease to be in force and effect on and from the date appointed by the Employer on that behalf, whereupon the Service Provider shall stop forthwith any of the Service then in progress, except such Service as the Employer may, in writing, require to be done to safeguard any property or work or installations from damage, and the Employer, for its part, may take over the Service remaining unfinished by the Service Provider and complete the same through another service provider or by other means, at the risk and cost of the Service Provider, and any of his sureties if any, shall be liable to the Employer for any excess cost occasioned by such service having to be so taken over and obtained by the Employer over and above the cost at the rates specified in the schedule of quantities and rate/prices.
- b) WITHOUT DETERMINING THE Contract to take over the Service of the Service Provider or any part thereof and complete the same through other service provider or by other means at the risk and cost of the Service Provider. The Service Provider and any of his sureties are liable to the Employer for any excess cost over and above the cost at the rates specified in the Schedule of Quantities/rates, occasioned by such services having been taken over and completed by the Employer.
- 2.11.2 In such events of Clause 2.11.1(a) or (b) above, the following shall be applicable: -
a) The whole or part of the Contract Performance Security furnished by the Service Provider is liable to be forfeited without prejudice to the right of the Employer to recover from the Service Provider the excess cost referred to in the sub-clause aforesaid. The Employer shall also have the right of taking possession and utilising in completing the services or any part thereof, such as materials, equipment and plants available at service site belonging to the Service Provider as may be necessary and

- the Service Provider shall not be entitled for any compensation for use or damage to such materials, equipment and plant.
- b) The amount that may have become due to the Service Provider on account of service already executed by him shall not be payable to him until after the expiry of Six (6) calendar months reckoned from the date of termination of Contract or from the taking over of the Service or part thereof by the Employer as the case may be, during which period the responsibility for faulty material or workmanship in respect of such services shall, under the Contract, rest exclusively with the Service Provider. This amount shall be subject to deduction of any amounts due from the Contract to the Employer under the terms of the Contract authorised or required to be reserved or retained by the Employer.
- 2.11.3 Before taking any action as per Clause 2.11.1(a) or (b) if in the judgment of the Employer, the default or defaults committed by the Service Provider is/are curable and can be cured by the Service Provider if an opportunity given to him, then the Employer may issue Notice in writing calling the Service Provider to cure the default within such time specified in the Notice.
- 2.11.4 The Employer shall also have the right to proceed or take action as per 2.11.1(a) or (b) above, in the event that the Service Provider becomes bankrupt, insolvent, compounds with his creditors, assigns the Contract in favour of his creditors or any other person(s) or being a company or a corporation goes into voluntary liquidation, provided that in the said events it shall not be necessary for the Employer to give any prior notice to the Service Provider.
- 2.11.5 Termination of the Contract as provided for in sub- clause 2.11.1(a) above shall not prejudice or affect their rights of the Employer which may have accrued up to the date of such termination.
- 2.12 **SERVICE PROVIDER REMAINS LIABLE TO PAY COMPENSATION IF ACTION NOT TAKEN UNDER CLAUSE 2.11**
If in any case in which any of the powers conferred upon the Employer by clause 2.11 thereof shall have become exercisable and the same had not been exercised, the non-exercise thereof shall not constitute a waiver of any of the conditions hereof and such powers shall notwithstanding be exercisable in the event of any further case of default by the Service Provider for which by any clause or clauses hereof he is declared liable to pay compensation amounting to the whole of his Contract Performance Security, and the liability of the Service Provider for past and future compensation shall remain unaffected. In the event of the Employer putting in force the power under above sub-clause 2.11 (a) or 2.11 (b) vested in him under the preceding clause he may, if he so desired, take possession of all or any tools and plants, materials and stores at the site thereof belonging to the Service Provider or procured by him and intended to be used for the execution of the Service or any part thereof paying or allowing for the same in account at the Contract rates or in case of these not being applicable, at current market rates to be certified by the EIC whose certificate thereof shall be final, otherwise the EIC may give notice in writing to the Service Provider or Service Provider's Representatives requiring him to remove such tools, plant, materials or stores from the premises (within a time to be specified in such notice). Failure of any action by the Service Provider for removal of material/tools/plant/store etc. within the period mentioned in notice of EIC, the Employer shall also be entitled to recover handling and storage charges @5% of the estimated value of material tools/plant/store for each month or part of a month without relieving the Service Provider from any other related liability.
- In the event of the Service Provider's failure to remove the same within a period of 6 months or as decided by the EIC, the EIC may take action for removal through auction or private sale on behalf of the Service Provider and at his risk in all respects. The Service Provider shall be liable to pay the Employer the handling & storage charges per month or a part of the month from the date of serving the notice by the EIC to the date of removal of the materials by the Employer plus overhead charges @ 15% of sale value of such materials. In case of negative or zero sale value, the overhead charges shall be applicable on the handling & storage charges. The decision of EIC w.r.t. such removal and the amount of the proceeds shall be final and binding on the Service Provider.
- 2.13 **CHANGE IN CONSTITUTION:**
Where the Service Provider is a partnership firm, the prior approval of the Employer shall be obtained in writing, before any change is made in the constitution of the firm. Where the Service Provider is an individual or a Hindu undivided family business concern, such approval as aforesaid shall, likewise be obtained before such Service Provider enters into any agreement with other parties, where under, the reconstituted firm would have the right to carry out the service hereby undertaken by the Service Provider. In either case if prior approval as aforesaid is not obtained, the Contract shall be deemed to have been allotted in contravention of clause 2.20 hereof.
- 2.14 **TERMINATION OF CONTRACT:**
- 2.14.1 **TERMINATION OF CONTRACT FOR DEATH**
If the Service Provider is an individual or a proprietary concern and the individual or the proprietor dies or if the Service Provider is a partnership concern and one of the partner dies then unless, the Employer is satisfied that the legal representative of the individual or the proprietary concern or the surviving partners are capable of carrying out and completing Contract, the Employer is entitled to cancel the Contract for the uncompleted part without being in any way liable for any compensation payment to the estate of the deceased Service Provider and/or to the surviving partners of the Service Provider's firm on account of the cancellation of Contract. The decision of the Employer/EIC in such assessment shall be final & binding on the parties. In the event of such cancellation, the Employer shall not hold the estate of the deceased Service Provider and/or the surviving partners of Service Provider's firm liable for any damages for non-completion of the Contract.
- 2.14.2 **TERMINATION OF CONTRACT IN CASE OF LIQUIDATION / BANKRUPTCY, ETC.**
If the Service Provider shall dissolve or become bankrupt or insolvent or cause or suffer any receiver to be appointed of his business or any assets thereof compound with his Creditors, or being a corporation commence to be wound up, not being a member's voluntary winding up for the purpose of amalgamation or reconstruction, or carry on its business under a Receiver for the benefits of its Creditors any of them, Employer shall be at liberty to terminate the Contract forthwith upon coming to know of the happening of any such event as aforesaid by notice in writing to the Service Provider or to give the Receiver or Liquidator or other person, the option of carrying out the Contract subject to his providing a guarantee up to an amount to be agreed upon by the Employer for due and faithful performance of the Contract.
- 2.14.3 **TERMINATION OF CONTRACT FOR CORRUPT / FRAUDULENT / COLLUSIVE / COERCIVE PRACTICES AND NON-PERFORMANCE**
If the Bidder/Service Provider is found to have indulged in Corrupt/ Fraudulent /Collusive/Coercive practices, the Contract shall be terminated and the Bidder/Service Provider shall be banned for future business with IREL.
- 2.14.4 **TERMINATION FOR CONVENIENCE**
Notwithstanding anything contained in the Contract, the Employer may, by 30 (Thirty) days written notice, terminate the Contract in whole or in part. In case of such termination, the obligation of the Employer to pay, shall be limited to the extent of work/job completed by the Service Provider as per provision of the Contract up to the date of termination, subject to the Service Provider complying with other terms of the Contract. Notwithstanding the termination of the Contract, the parties shall continue to be bound by the provisions of this Contract that reasonably require some action or forbearance after such termination.
- 2.15 **AMOUNT PAYABLE IN CASE OF TERMINATION:**
In all cases of termination herein set forth, the obligation of the Employer to pay, shall be limited to the extent of service rendered by Service Provider as per provision of the Contract up to the date of termination, subject to the Service Provider complying with other terms of the Contract. Notwithstanding the termination of the Contract, the parties shall continue to be bound by the provisions of this Contract that reasonably require some action or forbearance after such termination.
- 2.16 **MEMBERS OF THE EMPLOYER NOT INDIVIDUALLY LIABLE:**
No Director, or official or employee of the Employer shall in any way be personally bound or liable for the acts or obligations of the Employer under the Contract or answerable for any default or omission in the observance or performance of any of the acts, matters or things which are herein contained.
- 2.17 **EMPLOYER NOT BOUND BY PERSONAL REPRESENTATIONS:**
- 2.17.1 The Service Provider shall not be entitled to any increase on the scheduled rate or any other right or claim whatsoever by reason of any representation, explanation statement or alleged representation, promise or guarantees given or alleged to have been given to him by any person.
- 2.18 **FORCE MAJEURE:**
- 2.18.1 Force majeure is an event beyond the control of contractor and not involving the contractor's fault or negligence and which is not foreseeable. Such events may include, but are not restricted to acts of the purchaser/contractor either in its sovereign or contractual capacity, wars or revolution, hostility, acts of public enemy, civil commotion, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts and freight embargoes or any other event which IREL may deem fit to consider so. The decision about force majeure shall rest with IREL which shall be final and binding.
- 2.18.2 If there is delay in performance or other failures by the contractor to perform obligations under its contract due to event of a Force Majeure, the Service Provider shall not be held responsible for such delays/failures.
- 2.18.3 If a Force Majeure situation arises, the Service Provider shall promptly notify the purchaser in writing of such conditions and the cause thereof within fifteen days of

2.18.4 The Service Provider shall continue to perform its obligations under the contract as far as reasonable/practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

2.18.5 If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of Force Majeure for a period of exceeding 120 days, IREL may at its option terminate the contract without any financial repercussion on either side.

2.19 LIQUIDATED DAMAGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

2.20 ASSIGNMENT/SUBLET:

2.20.1 The Service Provider shall not, save with previous written consent of the Engineer-in-charge, sublet, transfer or assign the Contract or any part thereof or interest therein or benefit or advantage thereof in any manner whatsoever. Provided, nevertheless, that any such consent shall not relieve the Service Provider from any obligation, duty or responsibility under the Contract.

2.20.2 The basic scope of Services cannot be sublet. However, on specific request of the Service Provider and subject to written consent of Employer, the Service Provider may sublet allied/incidental jobs related to the Services. Such consent shall not relieve the Service Provider from any obligation, duty or responsibility under the Contract and Service Provider shall be fully responsible for the Services hereunder and the execution and performance of the Contract.

2.20.3 Sub-letting of whole Contract is prohibited. An undertaking to this effect will be given by Service Provider along with each invoice/ bill.

2.21 DELAYS BY EMPLOYER OR HIS AUTHORISED REPRESENTATIVE:

2.21.1 In case the Service Provider's performance is delayed due to any act or omission on the part of the Employer or his authorized Representative, then the Service Provider shall be given due extension of time for the completion of the Service, to the extent such omission on the part of the Employer has caused delay in the Service Provider's performance of his Services.

2.21.2 No adjustment in Contract Price shall be allowed for reasons of such delays and extensions granted except as provided in Tender Document, where the Employer reserves the right to seek indulgence of Service Provider to maintain the agreed Time Schedule of Completion. In such an event the Service Provider shall be obliged to provide Service for additional time beyond stipulated time including Off-days / Holidays or by enhancing resources to achieve the completion date/interim targets.

2.22 NO WAIVER OF RIGHTS:

2.22.2 None of the terms and conditions of this Contract shall be deemed waived by either party unless such waiver is executed in writing by the duly authorized representative of both the parties.

2.23 CERTIFICATE NOT TO AFFECT RIGHT OF EMPLOYER AND LIABILITY OF SERVICE PROVIDER:

2.23.1 No interim payment certificate(s) issued by the EIC of the Employer, nor any sum paid on account by the Employer, nor any extension of time for execution of the service granted by Employer shall affect or prejudice the rights of the Employer against the Service Provider or relieve the Service Provider of his obligations for the due performance of the Contract, or be interpreted as approval of the Service done and no certificate shall create liability for the Employer to pay for alterations, amendments, variations or additional services not ordered, in writing, by Employer or discharge the liability of the Service Provider for the payment of damages whether due, ascertained, or certified or not or any sum against the payment of which he is bound to indemnify the Employer.

2.24 LANGUAGE AND MEASURES:

2.24.1 All documents pertaining to the Contract including Specifications, Schedules, Notices, Correspondence, operating and maintenance Instructions or any other writing shall be written in English/Hindi language. The Metric System of measurement shall be used in the Contract unless otherwise specified.

2.25 RELEASE OF INFORMATION:

The Service Provider shall not communicate or use in advertising, publicity, sales releases or in any other medium, photographs, or other reproduction of the Service under this Contract or description of the site dimensions, quantity, quality or other information concerning the Service unless prior written permission has been obtained from the Employer.

2.26 COMPLETION PERIOD, CONTRACT PERIOD AND COMPLETION OF CONTRACT:

The Completion Period of Service and Contract Period shall be as mentioned in Special Conditions of Contract. Unless terminated under the provisions of any other relevant clause, this Contract shall be deemed to have been completed at the expiration of the Defect Liability Period as provided for under the Contract.

2.27 INDEPENDENT CAPACITY

The parties intend that an independent Service Provider relationship will be created by this Contract. The Service Provider and his/her employees or agents performing under this Contract are not employees or agents of the Employer. The Service Provider will neither hold himself/herself out as nor claim to be an officer or employee of the Employer by reasons hereof, nor will the Service Provider make any claim of right, privilege or benefit that would accrue to such employee under law. Conduct and control of work will be solely with the Service Provider.

2.28 NOTICE

2.28.1 TO THE SERVICE PROVIDER: Any notice to be given to the Service Provider or his duly authorised representative at the job Site under the terms of the Contract may be served by the Employer by facsimile / e-mail or through registered post/Courier at the address/contact information furnished by the Service Provider. Proof of issue of any such notice could be conclusive of the Service Provider having been duly informed of all contents therein.

2.28.2 TO THE EMPLOYER: Any notice to be given to the EIC of the Employer under the terms of the Contract may be served by the Service Provider, by facsimile / e-mail or delivering the same through registered post / Courier at the concerned site office.

2.28.3 Either party may change a nominated address to another address in the country where the Services are being provided by prior notice to the other party, with a copy to EIC and the EIC may do so by prior notice to both the parties. The decision of EIC in this regard shall be final and binding on the parties.

2.29 CONFIDENTIALITY:

The Service Provider, its Sub-Service Provider and their personnel shall not, either during the term or within two (2) years after the expiration of this Contract, disclose any proprietary or confidential information related to Service/project, this Contract, or Employer's business or operations without the prior written consent of the Employer.

- 2.30 **INTELLECTUAL PROPERTY RIGHT:**
The Service Provider shall retain the copy right and other intellectual property rights in the Service Provider's document and other design documents made by (or on behalf of) the Service Provider.
- Subject to the confidentiality obligations, by signing the Contract, within the Contract Price, the Service Provider shall be deemed to give to the Employer an non-terminable, transferable, non-exclusive and royalty-free right to copy, use and communicate the Service Provider's documents for the operation, maintenance, repair of the Service and Statutory purposes, but not for any other purpose. Such documents of the Service Provider shall not be used, copied or communicated to a third party by or on behalf of the Employer for the purposes other than those permitted, without the Service Provider's Consent.
- 3.0 **PERFORMANCE OF SERVICE**
- 3.1 **EXECUTION OF SERVICES:**
- 3.1.1 All Services shall be provided in strict conformity with the provisions of the Contract Documents and with such explanatory detailed specification and instruction as may be furnished from time to time to the Service Provider by EIC. The Service Provider shall undertake to perform all Services under this Contract with all reasonable skill, diligence and care in accordance with sound industry practice or international / national standards, wherever applicable (as the case may be) to the satisfaction of the Employer and accept full responsibility for the satisfactory quality of such services as performed by them.
- 3.2 **CHANGES IN SERVICES:**
- 3.2.1 During the performance of the Services, EIC / Employer may make a change in the Services within the general scope of this Contract including, but not limited to, changes in methodology and minor additions to or deletions from the Services and Service Provider shall render the service as changed. Changes of this nature will be affected by a written order (i.e., Amendment) by the Employer. The time of completion of the said job may be extended for the part of the particular job at the discretion of Engineer-In-Charge, for only such alterations or substitutions of the Services, as he may consider just and reasonable.
- 2.2.2 If any change result in an increase in compensation payable to Service Provider or in terms of a credit to be passed on to Employer, Service Provider shall submit to EIC an estimate of the amount of such compensation or credit in a form prescribed by Employer. Such estimates shall be based on the rates shown in the Schedule of Rates. Upon review of Service Provider's estimate, Employer shall establish and set forth in the written order the amount of the compensation or credit for the change or on a basis for determining a reasonable compensation or credit for the change.
- 3.3 **ACTION AND COMPENSATION IN CASE OF POOR SERVICE:**
If it shall appear to the EIC that any service has been rendered with unsound, imperfect or unskilled way, or with materials / manpower of any inferior description, or that any materials / manpower provided by the Service Provider for the execution of the Service are unsound, or of a quality inferior to that Contracted for, or otherwise not in accordance with the Contract, the Service Provider shall on demand in writing from the EIC or his authorized representatives specifying the Service, materials or manpower complained of notwithstanding that the same may have been inadvertently passed, certified and paid for, forthwith rectify the service so specified and at his own cost.
- 3.4 **SUSPENSION OF SERVICES:**
- 3.4.1 Subject to the provisions of sub-para 3.4.2 of this clause, the Service Provider shall, if ordered in writing by the EIC, temporarily suspend the Services or any part thereof for such written order and not proceed with the Service therein ordered to be suspended until, he shall have received a written order to proceed therewith. The Service Provider shall not be entitled to claim compensation for any loss or damage sustained by him by reason of temporary suspension of the Services aforesaid. An extension of time for completion, corresponding with the delay caused by any such suspension of the Services as aforesaid will be granted to the Service Provider should he apply for the same provided that the suspension was not consequent to any default or failure on the part of the Service Provider.
- 3.4.2 In case of suspensions of entire Service, ordered in writing by EIC, for a period of more than two months, the Service Provider shall have the option to terminate the Contract.
- 3.5 **DEFECTS LIABILITY PERIOD:**
- 3.5.1 The Service Provider unless otherwise specified elsewhere in the tender document shall guarantee the installation/Service for a period of 12 months / (any period as specified) from the date of completion of Service mentioned in the Completion Certificate issued by the EIC. Any damage or defect that may arise or lie undiscovered at the time of issue of Completion Certificate, connected in any way with the equipment or materials supplied by him or in the workmanship, shall be rectified or replaced by the Service Provider at his own expense as deemed necessary by the EIC. In case of default, the EIC may carry out such services by other service provider(s) and deduct actual cost incurred towards labour, supervision and materials consumables from any sums that may then be or at any time thereafter, become due to the Service Provider or from his Contract Performance Security, or the proceeds of sale thereof or a sufficient part on thereof. The decision of EIC in this regard shall be final and binding.
- 3.5.2 If the Service Provider feels that any variation in Service or in quality of materials or proportions would be beneficial or necessary to fulfill the guarantees called for, he shall bring this to the notice of the EIC in writing. If during the period of liability any portion of the Service/Equipment, is found defective and is rectified/ replaced, the period of liability of 12 months for such equipment/ portion of Service shall be operative from the date such rectification/ replacement are carried out and Contract Performance Guarantee shall be furnished separately for the extended period of liability for that portion of Service/ Equipment only. However, in no such case extension will exceed 24 months from the date of initial DLP. Notwithstanding the above provisions the supplier's, guarantees/warranties for the replaced/rectified Equipment/Service shall also be passed on to the Employer.
- 3.6 **LIMITATION OF LIABILITY**
Notwithstanding anything contrary contained herein, the aggregate total liability of Service Provider to Employer under the Contract shall not exceed the Total Contract Value, except that this clause shall not limit the liability of the Service Provider for following:
- (a) In the event of breach of any Applicable Law;
 - (b) In the event of fraud, wilful misconduct or illegal or unlawful acts, or gross Negligence of the Service Provider or any person acting on behalf of the Service Provider; or
 - (c) In the event of acts or omissions of the Service Provider which are contrary to the most elementary rules of diligence which a conscientious Service Provider would have followed in similar circumstances; or
 - (d) In the event of any claim or loss or damage arising out of infringement of Intellectual Property; or
 - (e) For any damage to any third party, including death or injury of any third party caused by the Service Provider or any person or firm acting on behalf of the Service Provider in executing the Works/Services.
- However, neither party shall be liable to the other Party for any indirect nor consequential loss or damage like loss of use, loss of profit, loss of production or business interruption which is connected with any claim arising under the Contract.
- 3.7 **INDEMNITY:**
If any action is brought before a Court, Tribunal or any other Authority against the Employer or an officer or agent of the Employer, for the failure, omission or neglect on the part of the Service Provider to perform any acts, matters, covenants or things under the Contract, or damage or injury caused by the alleged omission or negligence on the part of the Service Provider, his agents, representatives or his Sub-Service Provider's, or in connection with any claim based on lawful demands of Sub-Service Provider's service men suppliers or employees, the Service Provider, shall in such cases indemnify and keep the Employer and/or their representatives harmless from all losses, damages, expenses or decrees arising out of such action.
- 3.8 **DAMAGES TO PROPERTY, ANY PERSON AND THIRD PARTY**
- i) Service Provider shall be responsible for making good to the satisfaction of the Employer any loss or any damage to structures and properties belonging to the Employer or being executed or procured or being procured by the Employer or of other agencies within the premises of the Employer, if such loss or damage is due to fault and/or the Negligence or Wilful Misconduct or omission of the Service Provider, his employees, agents, representatives or Sub-Service Providers.
 - ii) The Service Provider shall take sufficient care in moving his equipment and materials from one place to another so that they do not cause any damage to any person or to the property of the Employer or any third party including overhead and underground cables and in the event of any damage resulting to the property of the Employer or of a third party during the movement of the aforesaid equipment or materials the cost of such damages including eventual loss of production, operation or services in any plant or establishment as estimated by the Employer or ascertained or demanded by the third party shall be borne by the Service Provider. Third party liability risk shall be Rupees One lakh for single accident and limited to Rupees Ten lakhs.
 - iii) The Service Provider shall indemnify and keep the Employer harmless of all claims for damages to property other than Employer's property arising under or by reason of this agreement, if such claims result from the fault and/or Negligence or Wilful Misconduct or omission of the Service Provider, his employees, agents, representative of Sub-Service Provider.
- 4.0 **PAYMENT, INSURANCE AND TAXES**

- 4.1 **DEDUCTION FROM THE CONTRACT PRICE:**
- 4.1.1 All costs, damages or expenses which Employer may have paid or incurred, which under the provisions of the Contract, the Service Provider is liable to pay to the Employer. All such claims shall be claimed by the Employer from the Service Provider regularly as and when they fall due. Such claims shall be paid by the Service Provider within 15 (fifteen) days of the receipt of the corresponding bills/ claims and if not paid by the Service Provider within the said period, the Employer may, then, deduct the amount from any immediate moneys due to the Service Provider like R.A Bills, Final Bills, Contract Performance Security or any payment becoming due to the Service Provider under the Contract or may be recovered by actions of law or otherwise, if the Service Provider fails to satisfy the Employer of such claims.
- 4.2 **SCHEDULE OF RATES AND PAYMENTS:**
- 4.2.1 **SERVICE PROVIDER'S REMUNERATION:**
The price to be paid by the Employer to Service Provider for the whole of the Service to be done and for the performance of all the obligations undertaken by the Service Provider under the Contract Documents shall be ascertained by the application of the respective Schedule of Rates (the inclusive nature of which is more particularly defined by way of application but not of limitation, with the succeeding sub-clause of this clause) and payment to be made accordingly for the Services actually executed and approved by the Engineer-in-Charge. The sum so ascertained shall (except only as and to the extent expressly provided herein) constitute the sole and inclusive remuneration of the Service Provider under the Contract and no further or other payment whatsoever shall be or become due or payable to the Service Provider under the Contract.
- 4.2.2 **SCHEDULE OF RATES TO BE INCLUSIVE:**
The prices/rates quoted by the Service Provider shall remain firm till the issue of Final Certificate and shall not be subject to escalation. Schedule of Rates shall be deemed to include and cover all costs, expenses and liabilities of every description and all risks of every kind to be taken in rendering the services to the Employer by the Service Provider. The Service Provider shall be deemed to have known the nature, scope, magnitude and the extent of the service though the Contract Document may not fully and precisely furnish/specify them. The Tenderer shall be deemed to include the requisite services as may be required to complete the Services properly including remedying of any defect therein.
- 4.2.3 **SCHEDULE OF RATES TO COVER CONSTRUCTION EQUIPMENTS, MATERIALS, LABOUR ETC.:**
Without in any way limiting the provisions of the preceding sub-clause the Schedule of Rates shall be deemed to include and cover the cost of all construction equipment, temporary work (except as provided for herein), pumps, materials, labour, insurance, fuel, consumables, stores & appliances and such other items / equipment's / materials as required for carrying out the services by the Service Provider and all other matters in connection with each item in the Schedule of Rates and the execution of the Service or any portion thereof finished, complete in every respect and maintained as shown or described in the Contract Documents or as may be ordered in writing during the continuance of the Contract.
- 4.2.4 **SCHEDULE OF RATES TO COVER ROYALTIES, RENTS AND CLAIMS:**
The Schedule of Rates (i.e., Value of Contract) shall be deemed to include and cover the cost of all royalties and fees for the articles and processes, protected by letters, patent or otherwise incorporated in or used in connection with the Service, also all royalties, rents and other payments in connection with obtaining materials of whatsoever kind for the Service and shall include an indemnity to the Employer which the Service Provider hereby gives against all actions, proceedings, claims, damages, costs and expenses arising from the incorporation in or use in the Service of any such articles, processes or materials, octroi or other municipal or local Board Charges, if levied on materials, equipment or machineries to be brought to site for use for Services shall be borne by the Service Provider.
- 4.2.5 **SCHEDULE OF RATES TO COVER TAXES AND DUTIES:**
No exemption or reduction of Customs Duties, GST, Works Contract Tax or any port dues, transport charges, stamp duties or Central or State Government or local Body or Municipal Taxes or duties, taxes or charges (from or of any other body), entry tax, whatsoever, will be granted or obtained, all of which expenses shall be deemed to be included in and covered by the Schedule of Rates, unless mentioned specifically elsewhere in the Tender Document. The Service Provider shall also obtain and pay for all permits/licenses or other privileges necessary to complete the Service.
- 4.2.6 **SCHEDULE OF RATES TO COVER RISKS OF DELAY:**
The Schedule of Rates shall be deemed to include and cover the risk of all possibilities of delay and interference with the Service Provider's conduct/performance of Services which occurs from any causes including orders of the Employer in the exercise of his power and on account of extension of time granted due to various reasons and for all other possible or probable causes of delay.
- 4.2.7 **SCHEDULE OF RATES CANNOT BE ALTERED:**
For Service under unit rate basis, no alteration will be allowed in the Schedule of Rates by reason of services or any part of them being modified, altered, extended, diminished or committed. The Schedule of Rates are fully inclusive of rates which have been fixed by the Service Provider and agreed to by the Employer and cannot be altered. For lumpsum Contracts, the payment will be made according to the Service actually carried out, for which purpose an item wise, or work wise Schedule of Rates shall be furnished, suitable for evaluating the value of Service provided and preparing running account bill. Payment for any additional Service which is not covered in the Schedule of Rates shall only be released on issuance of Amendment to LOA/ Contract by the Employer.
- 4.3 **PROCEDURE FOR BILLING OF SERVICES:**
- 4.3.1 **BILLING PROCEDURE:**
Following procedures shall be adopted for billing of services executed by the Service Provider.

The Bill(s) complete in all respect with details and enclosure(s) is to be submitted by Service Provider in line with terms of the Contract. Employer shall make all endeavour to release payments of undisputed amount of the bills submitted within 30 (Fifteen) days from the date of receipt of Bills by the Engineer-in-Charge.
- 4.3.2 **MODE OF MEASUREMENT:**
The payment shall be made based on the mode of measurement as specified in the Contract. Otherwise, the mode of measurement shall be adopted as per latest Indian Standard Specifications.
- 4.4 **NOTICE OF CLAIMS FOR ADDITIONAL PAYMENTS:**
- 4.4.1 Should the Service Provider consider that he is entitled to any extra payment for any extra/additional Job(s)/Service(s) or material change in original Specifications carried out by him in respect of job, he shall forthwith give notice in writing to the Engineer-in-Charge that he claims extra payment. Such notice shall be given to the Engineer-in-Charge upon which Service Provider bases such claims and such notice shall contain full particulars of the nature of such claim with full details of amount claimed. Irrespective of any provision in the Contract to the contrary, the Service Provider must intimate his intention to lodge claim on the Employer within 10 (ten) days of the commencement of happening of the event and quantify the claim within 30 (thirty) days, failing which the Service Provider will lose his right to claim any compensation/ reimbursement/ damages etc. Failure on the part of Service Provider to put forward any claim without the necessary particulars as above within the time above specified shall be an absolute waiver thereof. No omission by Employer to reject any such claim and no delay in dealing therewith shall be a waiver by Employer of any of these rights in respect thereof.
- 4.4.2 Engineer-in-Charge shall review such claims within a reasonable period of time and cause to discharge these in a manner considered appropriate after due deliberations thereon. However, Service Provider shall be obliged to carry on with the Jobs/services during the period in which his claims are under consideration by the Employer, irrespective of the outcome of such claims, where additional payments for Services considered extra are justifiable in accordance with the Contract provisions. Employer shall arrange to release the same in the same manner as for normal job payments. Such of the extra services so admitted by Employer shall be governed by all the terms, conditions, stipulations and specifications as are applicable for the Contract. The rates for extra services shall generally be the unit rates provided for in the Contract. In the event unit rates for extra services so executed are not available as per Contract, payments may either be released on day work basis for which daily/hourly rates for workmen and hourly rates for equipment rental shall apply, or on the unit rate for Services executed shall be derived by interpolation/ extrapolation of unit rates already existing in the Contract. In all the matters pertaining to applicability of rate and admittance of otherwise of an extra service claim(s) of Service Provider, the decision of Engineer-in-Charge shall be final and binding on the Service Provider.
- 4.5 **INSURANCE:**
- 4.5.1 Service Provider shall, at his own expense, arrange appropriate insurance to cover all risks assumed by the Service Provider under this Contract in respect of its personnel deputed under this Contract as well as Service Provider's equipment, tools and any other belongings of the Service Provider or their personnel during the entire period of their engagement in connection with this Contract. Employer will have no liability on this account. The Personnel covered must be covered to meet the liability under Employee Compensation Act.
- 4.5.2 The provisions of this Clause shall in no way limit the liability of the Service Provider under the Contract.
- 4.5.3 If the Service Provider neglects, fails, or refuses to obtain or maintain insurances required to be affected, or fails to provide certification etc., the Employer has the right to

procure and maintain policies at Service Provider's expense plus administrative cost of 10% of the amount of Insurance premium.

4.5.4 INSURANCE TYPES:

Service Provider shall at all time during the currency of the Contract provide, pay for and maintain the following insurance amongst others:

- 4.5.4.1 Employee Compensation and Employer's common law liability insurance covering liability to employees of the Service Provider under the laws of their place or employment or place of injury, arising out of injury sustained in connection with any of the services. This insurance will be extended where submitted by law, to indemnify the Employer against any statutory liability which it may incur towards injured employees of the Service Provider. A proof of the same should be submitted to EIC for liability in line with Employees Compensation Act.
- 4.5.4.2 General Public Liability Insurance covering liabilities including contractual liability for bodily injury, including death of persons, and liabilities for damage of property. This insurance must cover all operations of Service Provider required to fulfil the provisions under this Contract.
- 4.5.4.3 Service Provider's Equipment/Materials/Goods used for execution of the work hereunder shall have an insurance cover with a suitable limit (as per international standards).
- 4.5.4.4 Automobile Public Liability Insurance covering owned, non-owned and hired automobiles used in the performance of the work hereunder, with bodily injury limits and property damage limits as governed by Indian Insurance regulations.
- 4.5.4.5 Service Provider shall obtain additional insurance or revise the limits of existing insurance as per Employer's request in which case additional cost shall be to Service Provider's account. Further, the Service Provider shall ensure the adequacy of Insurance at all time in accordance with the nature of the Service(s), terms of the Contract and Statutory requirements.

4.5.6 **CERTIFICATE OF INSURANCE:**

Before commencing performance of the services, Service Provider shall on request furnish EIC/Employer with certificates of insurance indicating:

- i) type and amounts of insurance as required herein;
- ii) insurance company or companies carrying the aforesaid coverage;
- iii) effective and expiry dates of policies;
- iv) that the Employer may give advance notice for any material change in the policy. waiver of subrogation endorsement has been attached to all policies; and
- v) the territorial limits of all policies.
- 4.5.7 If any of the above policies expire or are cancelled during the terms of the service, and Service Provider fails for any reason to renew such policies, the Employer may replace same and recover the charges towards premium plus administrative charges from Service Provider. Should there be a lapse in any insurance required to be carried out by the Service Provider hereunder for any reason, losses & penalty, if any resulting therefrom shall be to the sole account of the Service Provider.

4.5.8 Service Provider shall require all its Sub-Service Providers to provide such foregoing insurance cover as the Service Provider is obligated to provide under the Contract.

4.5.9 WAIVER OF SUBROGATION: All insurance policies of the Service Provider with respect to the operations conducted hereunder, shall be endorsed by the underwriter in accordance with the following policy wording: "The insurers hereby waive their rights of subrogation against any individual, Employer, affiliates or assignees for whom or with whom the assured may be operating to the extent of the Contractual indemnities undertaken by the Service Provider".

4.5.10 Deductible: That portion of any loss not covered by insurance provided for in this article solely by reason of deductible provision in such insurance policies shall be to the account of the Service Provider.

4.6 **TAXES AND DUTIES:**

4.6.1 The Service Provider, unless specified otherwise elsewhere in the Contract agrees to and does hereby accept full and exclusive liability for the payment of any and all Taxes, Duties, including GST now or hereafter imposed, increased, modified from time to time in respect of Services and materials and all contributions and taxes for unemployment compensation, insurance and old age pensions or annuities now or hereafter imposed by any Central or State Government authorities which are imposed with respect to or covered by the wages, salaries, or other compensations paid to the persons employed by the Service Provider and the Service Provider shall be responsible for the compliance of all Sub-Service Providers, with all applicable Central, State, Municipal and local law and regulation and requirement of any Central, State or local Government agency or authority. Service Provider further agrees to defend, indemnify and hold Employer harmless from any liability or penalty which may be imposed by the Central, State or Local authorities by reason of any violation by Service Provider or Sub-Service Provider of such laws, suits or proceedings that may be brought against the Employer arising under, growing out of, or by reason of the service provided for by this Contract, by third parties, or by Central or State Government authority or any administrative sub-division thereof. Tax deductions will be made as per the rules and regulations in force in accordance with acts prevailing from time to time.

4.6.2 Service Provider shall ensure timely submission of correct invoice(s) with all required supporting document(s) as per Contract within a period specified in Contracts to enable Employer to avail Input Tax Credit.

If Input Tax credit with respect to GST is not available to Employer for any reason which is not attributable to Employer, then Employer shall not be obligated or liable to pay or reimburse GST charged in the invoice(s) and shall be entitled to / deduct / set off / recover the such GST together with all penalties and interest if any, against any amounts paid or payable by Employer to Service Provider.

4.6.3 Where Employer has the obligation to discharge tax liability under reverse charge mechanism and Employer has paid or is / liable to pay GST to the Government on which interest or penalties becomes payable as per rules (as amended from time to time) for any reason which is not attributable to Employer or Input Tax credit with respect to such payments is not available to Employer for any reason which is not attributable to Employer, then Employer shall be entitled to deduct / set off / recover such amounts against any amounts paid or payable by Employer to Service Provider.

4.7 **INCOME TAX:**

Income Tax deduction shall be made from all payments of the Service Provider as per rules and regulation in force in accordance with the Income Tax Act prevailing from time to time.

4.8 **STATUTORY VARIATIONS:**

4.8.1 All duties, taxes (except where otherwise expressly provided in the Contract) as may be levied / imposed in consequences of execution of the Jobs/Services or in relation thereto or in connection therewith as per the Acts, Laws, Rules, Regulations in force on the due date of submission of Bid for this Contract shall be to Service Provider's account. Any increase / decrease in such duties, taxes after the due date of submission of bid but within the Contractual completion date as stipulated in the Contract will be to the account of Employer subject to submission of documentary proof to the satisfaction of Employer.

4.8.2 Any increase in the duties and taxes after the Contractual completion period will be to the Service Provider's account, where delay in completion / mobilization period is attributable to the Service Provider and the taxes & duties are not cenvatable (i.e., Input Tax Credit (ITC) not available). In case of applicability of ITC / cenvatable taxes & duties, payment shall be made as per the prevailing rates during the currency of the Contract. However, any benefit of decrease in duties and taxes after the Contractual completion will be passed on to the Employer.

In the event of introduction of any new legislation or any change or amendment or enforcement of any Act or Law, rules or regulations of Government of India or State Government(s) or Public Body which becomes effective after the due date of submission of Bid for this Contract but within the Contractual completion period (including extended period allowed due to reasons attributed to Employer) and which results in increased cost of the jobs/services under the Contract through increased liability of taxes, (other than personnel and Corporate taxes), duties, the Service Provider shall be indemnified for any such increased cost by the Employer subject to the production of documentary proof to the satisfaction of the Employer to the extent which directly is attributable to such introduction of new legislation or change or amendment as mentioned above and adjudication by the competent authority & the courts wherever levy of such taxes / duties are disputed by Employer.

4.8.3 Similarly, in the event of introduction of new legislation or any change or amendment or enforcement of any Act or Law, rules or regulations of Government of India or State Government(s) or Public Body which becomes effective after the due date of submission of Bid for this Contract and which results in any decrease in the cost of the services/ jobs through reduced liability of taxes, (other than personnel and Corporate taxes) duties, the Service Provider shall pass on the benefits of such reduced cost, taxes or duties to the Employer, to the extent which is directly attributable to such introduction of new legislation or change or amendment as mentioned above.

5.0 **LAWS, HEALTH, SAFETY & ENVIRONMENT**

5.1 **LABOUR LAWS:**

- i) No labour below the age of 18 (eighteen) years shall be employed on the Job.
- ii) The Service Provider shall not pay less than what is provided under law to labourers engaged by him on the Job.
- iii) The Service Provider shall at his expense comply with all labour laws and keep the Employer indemnified in respect thereof.
- iv) The Service Provider shall pay equal wages for men and women in accordance with applicable labour laws.
- v) If the Service Provider is covered under the Contract labour (Regulation and Abolition) Act, he shall obtain a license from licensing authority (i.e., office of the labour

- commissioner) by payment of necessary prescribed fee and the deposit, if any, before starting the Job under the Contract. Such fee/deposit shall be borne by the Service Provider.
- vi) The Service Provider shall employ labour in sufficient numbers either directly or through Sub-Service Provider's to maintain the required rate of progress and of quality to ensure workmanship of the degree specified in the Contract while also ensuring that workman is not stressed due to long hour of working and to the satisfaction of the EIC.
 - vii) The Service Provider shall furnish to the EIC the distribution return of the number and description, by trades of the service people employed on the services. The Service Provider shall also submit to the EIC a true statement showing in respect of the second half of the preceding month and the first half of the current month the accidents that occurred during the said fortnight showing the circumstances under which they happened and the extent of damage and injury caused by them and (2) the number of female workers who have been allowed Maternity Benefit as provided in the Maternity Benefit Act 1961 on Rules made thereunder and the amount paid to them.
 - viii) The Service Provider shall comply with the provisions of the payment of Wage Act 1936, Employee Provident Fund Act 1952, Minimum Wages Act 1948. Employers Liability Act 1938, Servicemen's Compensation Act 1923, Industrial Disputes Act 1947, the Maternity Benefit Act 1961 and Contract Labour Regulation and Abolition Act 1970, Employment of Children Act 1938 or any modifications thereof or any other law relating thereto and rules made thereunder from time to time.
 - ix) The EIC shall on a report having been made by an Inspecting Officer as defined in Contract Labour (Regulation and Abolition) Act 1970 have the power to deduct from the money due to the Service Provider any sum required or estimated to be required for making good the loss suffered by a worker or workers by reason of non-fulfilment of the Conditions of the Contract for the benefit of workers, non-payment of wages or of deductions made from his or their wages which are not justified by the terms of the Contract or non-observance of the said regulations.
 - x) The Service Provider shall indemnify the Employer against any payments to be made under and for the observance of the provisions of the aforesaid Acts without prejudice to his right to obtain indemnity from his Sub-Service Provider's.
- 5.2 SAFETY REGULATIONS:
- i) In respect of all labour, directly employed in the Service for the performance of Service Provider's part of this agreement, the Service Provider shall at his own expense arrange for all the safety provisions as per safety codes of acts as applicable.
 - ii) The Service Provider shall observe and abide by all fire and safety regulations of the Employer. Before starting service, Service Provider shall consult with Employer's safety Engineers or EIC and must make good to the satisfaction of the Employer any loss or damage due to fire to any portion of the service done or to be done under this agreement or to any of the Employer's existing property.
- 5.3 FIRST AID AND INDUSTRIAL INJURIES:
- i) Service Provider shall maintain first aid facilities for its employees and those of its Sub-Service Provider.
 - ii) Service Provider shall make outside arrangements for ambulance service and for the treatment of industrial injuries. Names of those providing these services shall be furnished to Employer prior to start and their telephone numbers shall be prominently posted in Service Provider's field office.
 - iii) All critical industrial injuries shall be reported promptly to Employer, and a copy of Service Provider's report covering each personal injury requiring the attention of a physician shall be furnished to the Employer.
- 5.4 GENERAL RULES:
- Smoking within the battery area, tank farm, dock limits or any such area identified by EIC or mentioned in SCC or any guideline, is strictly prohibited. Violators of the no smoking rules shall be discharged immediately after imposing the applicable penalty(ies). Decision of EIC in the matter shall be final and binding on the Service Provider.
- 5.5 CARE IN HANDLING INFLAMMABLE GAS:
- The Service Provider has to ensure all precautionary measures and exercise utmost care in handling the inflammable gas cylinder/inflammable liquids/paint etc. as required under the law and/or as advised by the fire Authorities of the Employer.
- 5.6 PRESERVATION OF PLACE:
- The Service Provider shall take requisite precautions and use his best endeavours to prevent any riotous or unlawful behaviour by or amongst his worker / personnel employed for the services and for the preservation of peace and protection of the inhabitants and security of property in the neighbourhood of the Site. In the event of the Employer requiring the maintenance of a Special Police Force at or in the vicinity of the site during the tenure of services, the expenses thereof shall be borne by the Service Provider and if paid by the Employer shall be recoverable from the Service Provider.
- 5.7 ENVIRONMENT:
- 5.7.1 Employer acknowledges their commitment to conduct their respective operations in a manner which not only complies with all relevant environmental protection and pollution control legislation but also such operations do not cause environmental damage or pollution and in a manner which acknowledges other cultural and associated considerations. In recognition of this commitment, the Service Provider shall perform the services in such a way as to avoid or minimize environmental damage or pollution and fully recognize the special aspects of the environment as communicated by Employer or as applicable. Service Provider shall comply with, and the Service Provider shall ensure compliance with all applicable environmental protection and pollution control legislation as it relates to the services.
- 6.0 RESOLUTION OF DISPUTES/ ARBITRATION:
- 6.1 The EMPLOYER and the CONTRACTOR shall make every effort to resolve amicably by direct informal, good faith negotiations any disagreement or dispute arising between them under or in connection with the Contract.
- 6.2 If, after thirty days from the commencement of such informal, good faith negotiations, the EMPLOYER and the CONTRACTOR have been unable to resolve the disagreement or dispute, the same shall be referred for resolution as per the formal mechanism as specified hereunder shall be applicable.
- 6.3 LEGAL CONSTRUCTION: The Contract shall be, in all respects be construed and operated as an Indian Contract and in accordance with Indian Laws as in force for the time being.
- 6.4 ARBITRATION:
- a) All disputes and differences of any kind whatsoever arising out of or in connection with the contract or carrying out of the works (whether during the course of works or after their completion and whether before or after determination, abandonment or breach of contract) shall be referred to and settled by the person authorized and notified in writing by IREL who shall state his decision in writing. Such a decision may be in the form of a final certificate or otherwise and shall be made within a period of 30 days from the date of receipt of such reference to them.
 - b) If the CONTRACTOR is dissatisfied with the decision of such authorized person, then he may within 30 days of receipt of such decision send a written appeal to PURCHASER, represented by the Chairman and Managing Director at the registered office, Mumbai for the same to be referred to Arbitration by a Sole Arbitrator to be appointed by mutual consent and after due approval of CMD, IREL. The Arbitration proceedings shall be conducted as per the provisions of the Arbitration and Conciliation Act, 1996. It is made clear that this Arbitration Clause shall be applicable to any and all disputes and differences between the Parties arising out of and/or relating to this CONTRACT and the Parties shall be bound to refer the same to arbitration in accordance with the procedure contemplated herein.
 - c) If the period of 30 days under Clause (b) has expired at any stage, stipulated in the preceding paras without any response from the CONTRACTOR before such expiry, the CONTRACTOR is deemed to have communicated his satisfaction to the decision of IREL at the relevant stage and all his rights of further appeal or as the case may be, adjudication is deemed to have been waived once and for all.
 - d) The seat of arbitration will be at Mumbai and the language thereof shall be English.
 - e) Notwithstanding the invocation, commencement and/or pendency any dispute resolution proceedings under this Clause including arbitration under Clause 6.4, the CONTRACTOR shall continue to be bound by the provisions of the CONTRACT, if not terminated by the EMPLOYER, and shall be obligated to discharge its obligations under the CONTRACT including continuation of the WORK under the CONTRACT.
 - f) The CONTRACTOR shall not in any way delay or default or cause to delay or default the carrying out of the works by reason of the fact that any matter has been agreed to be referred to and / or referred to dispute resolution under Clause 6.3 including Arbitration under Clause 6.4.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
